### 48 Lake Dr. Toni Mantel (RDA#2020-01)

Ms. Mantel was present at the meeting as well as Mr. Nate Cosper, Brady Built Sunrooms representative. Mr. Cosper explained the construction of the sunroom on the existing footprint of the deck would not cause any earth removal as they are using helical screws for the foundation of the sunroom. The Commission requested straw wattles be put into place and the applicant and Mr. Cosper agreed to installing the wattles.

MOTION: Ms. Schold moved to approve the RDA with a negative 3 determination as the work is in the buffer zone but will not impact the buffer zone.

### **Mulberry Solar 3 update**

Project manager, Ashlesh Kurahatti, Senior project manager Patreek Tare, and engineer Devin Howe from Beals and Associates presented information, in packet form (the same packet given to the Planning Board at the last meetings). Mr. Bryan Milward explained to the Commission

that the Planning Board issued a Cease & Desist Order on the project until Kevin Quinn from Quinn Engineering walked the site and Jarvis Land Survey had been approved to go out and do a site walk. Mr. Milward explained Jarvis has been hired to go out and do the site walk and survey and he would be facilitating a meeting between Jarvis and the representatives of Mulberry Solar 3 hopefully by the end of the week. Mr. Milward told the commission he would let them know when the meeting is set for so the applicant can start site stabilization. [No other work besides site stabilization may occur until the Cease & Desist Order is lifted by the Planning Board.]. There was a brief discussion regarding upcoming weather and if it would be a factor in stabilization/erosion.
