# **Public Application**

## Request for Lot Releases, Oakridge Estates

Ms. Buck reviewed from the last meeting that the applicant could not get any lot releases approved until the amount of the Letter of Credit increase was approved by the Bank. The Board had asked for a status update from the applicant, which was submitted. They've started the road paving process and requested that the Board act on the lot release request. Ms. Buck noted that before any sign off, the work will need completed and be inspected by the Town Engineer. The applicant also agreed to the paperwork being held in the Planning Office until the paving was actually finished. The two requests being made were: 1) for a release of all the lots in Phase 3; and 2) releasing the new/revised unit numbers in Phase 1 approved at the amendment hearing.

Hearing no further discussion; Mr. Grimshaw asked for a motion.

MOTION: Ms. Nist moved to: 1) approve the Conditional Partial Release of Covenant (the Release) for units 1, 2, & 75 of Phase 1 Oakridge Estates; and 2) approve the Conditional Partial Release of Covenant (the Release) for all units in Phase III Oakridge Estates, conditioned upon completion of the base coat of pavement in Phase III. The original Release document for Phase III will be held in the Planning Office until this work is completed to the satisfaction of the Town Engineer.

## • Boutilier Solar

The project is completed & area looks good ---Kevin Quinn will be checking with the Highway Department regarding the entrance and as long as that was done correctly, the Board can sign off on occupancy.

#### • Cumberland Farms

The demolition permit to take down the old Exxon building will be applied for soon.

#### • Central Mass Crane

Ms. Buck signed off on the occupancy permit after a site visit was done. A complaint was later received by a neighbor regarding the site lighting. Ms. Buck noted that what was approved by the Board was what the applicant installed. She and Mr. Grimshaw did a night-time site visit and they felt the lighting on the property was not excessive and placed as shown on the plan. Kevin Quinn will be asked to check out the lighting on the site.

#### • 104 Huntoon Memorial

Mr. Wright asked for an update. Several calls have been received on the property owner possibly cutting into the wetlands. The Conservation Commission has asked the property owner to file a Request for Determination of Applicability (RDA) to review the work being conducted on that site. That meeting is on November 18, 2015. Planning Board Site Plan Review will also be needed for a proposed new building.

## • New Application

A site plan review application was received [from Verizon Wireless] for a cell tower to be placed at 30 Huntoon Memorial Highway and that will be heard at the Board's December 15, 2015 meeting.
