CALL TO ORDER/OPENING

Mr. Genereux reviewed the draft Annual Town Meeting warrant with the Select Board and Finance Advisory Board. Mr. Genereux noted that version 2 of the warrant will be coming out on Thursday.

b. 6:30pm - Proclamation for Retired Deputy Fire Chief Donald Berube

Citations and proclamations were presented to retired Deputy Fire Chief Donald Berube in honor of his 41 years of service to the Town of Leicester.

3. NEW BUSINESS

a. Appointment – Town Hall Renovations Committee At Large Position – Robert Wilson

A motion was made by Ms. Provencher and seconded by Mr. Green to appoint Robert Wilson to the Town Hall Renovations Committee at-large position. The motion carried with one abstention (Ms. Wilson).

b. Appointment – Inspector of Animals - Janet King (reappointment)

A motion was made by Ms. Provencher and seconded by Mr. Green to reappoint Janet King to the position of Inspector on Animals. The motion carried unanimously.

c. Appointment – Leicester Housing Authority Commissioner

A motion was made by Ms. Wilson and seconded by Ms. Provencher to appoint Dick Hammerstrom to the Leicester Housing Authority Board of Commissioners as the State's appointee effective June 13, 2018. The motion carried unanimously.

February Department Reports were included in the Board packet. No questions were asked.
