The restaurant seats 41 customers and will initially be open for breakfast and lunch only with fish and chips on Fridays. A motion was made by Ms. Wilson and seconded by Ms. Provencher to approve the Common Victualler license for B-Law's Diner and to set the hours from 5am-11pm Monday - Sunday.
