A brook, starting 1500 feet upstream within my neighborhood, runs through my yard from north to south. The banks of the brook are 6 feet deep from the property ground surface with trees and underbrush lining the edge of the banks.

2. a. Work Description (use additional paper and/or provide plan(s) of work, if necessary):

Cut three trees at the base of the trunk and trim other trees near the residential structure. The trees are located on the east bank of the brook, closest to the home. All three have a trunk diameter of 12 inches. Two trees have historically had a clothes line wrapped around them which will cause suffocation and death of the trees. A third tree has signs of rot and splitting at the base of the trunk. All three are being removed proactively to prevent damage to the residential structure. Stumps and root balls will remain in place so as not to disturb the banking. Further trimming of two large pine trees and other underbrush will be performed to allow for sunlight and air circulation along that side of the house. The northwest corner of the home shows growth of moss and lichen along the roof and siding from the shade and dampness harbored by the trees which were allowed to grow along the banking 20 feet from the home. All work will be done by a professional tree service with respect to continued health of the trees and removal of trees with minimal disruption to the banking or brook.









7 Three pre-existing tree stumps 20 feet away from brook. I want to grind but leave root structure and chippings in place, no disruption to ground surface or water flow into brook.
