RE: NOI application for 29 Rawson Drive

When my wife and I purchased our property at 29 Rawson Drive in April of 2009 we did not yet have any children and had not yet decided on starting a family. We had always wanted to live on the water so that if we did decide to have children there would be plenty of outdoor activities. We were unaware that the property was zoned as agricultural and figured that we would be able to add on down the road if we needed additional space. Unbeknownst to us when we purchased the home, there was a pending lawsuit against the lake association. Soon after learning of the lawsuit, our assessment increased by 30k and a snapshot was taken on this new figure of which our portion of the lawsuit was based upon. We loved the property but struggled with the financial decision we had made when we purchased the home just after the overinflated market crashed, when home prices were dropping but still high, and now we owed an additional 25k as a result of the lawsuit. Despite the unfortunate financial setbacks, over time we grew to love our neighbors, our lake and just relaxing in our back yard. We decided to start a family and three children later we have outgrown our 2 bedroom home. Our daughter is in Kindergarten and Julian our middle child will start preschool next year at Leicester Primary school. My daughter loves her school and her teachers and my son cannot wait to start and ride the bus with his big sister. We have made friends around the lake and in the summer make frequent stops in our boat for the children to talk to their new friends. The house and the town have grown on us and we are hoping to add on as we are simply out of room. In addition to the shortage of bedrooms, we have had to pay for a storage unit for over 8 years as the house does not have an attic or a basement.

Due to the SA zoning and the small lot we are limited in options and unable to work with the current footprint. The 40 foot setbacks currently land somewhere inside our existing home. The proposed addition will use the same footprint on 3 sides and will not be expanded on the waterfront side of the

property. The expansion will include a small garage with living space above on the road side of the property. Furthermore, our living room and utility room are currently sitting on an old block foundation. As part of this project these will be taken down and rebuilt on a proper foundation which will strengthen the home and eliminate moisture in the crawl space. The utility room will be expanded into the new garage space in order to allow for an additional furnace which will deliver heat to floor registers which will be installed on the entire lower level (currently we only have ceiling heat on the first floor which quickly escapes to the second level). In addition we will be looking to have a well drilled as currently we have a shallow well which does not produce drinkable water. These improvements in addition to the proposed garage and living space above will allow our family to stay in our home for many years. The zoning board has approved the Special Permit and Variance for the new design. We are hoping that the proposed plans with the Silt fence and hay barrier will satisfy the requirements of the conservation board.

WETLAND RESOURCE / EXISTING CONDITIONS REPORT

The site consists of a 17,049 sq. ft. lot on Cedar Meadow Pond that has been fully developed over the years and consists of grass lawn; a driveway and a beachfront area; there has been no natural or preexisting vegetation on this site for years,

The property topography is predominately flat with a gentle slope towards the pond. All structures are not in a flood plain.

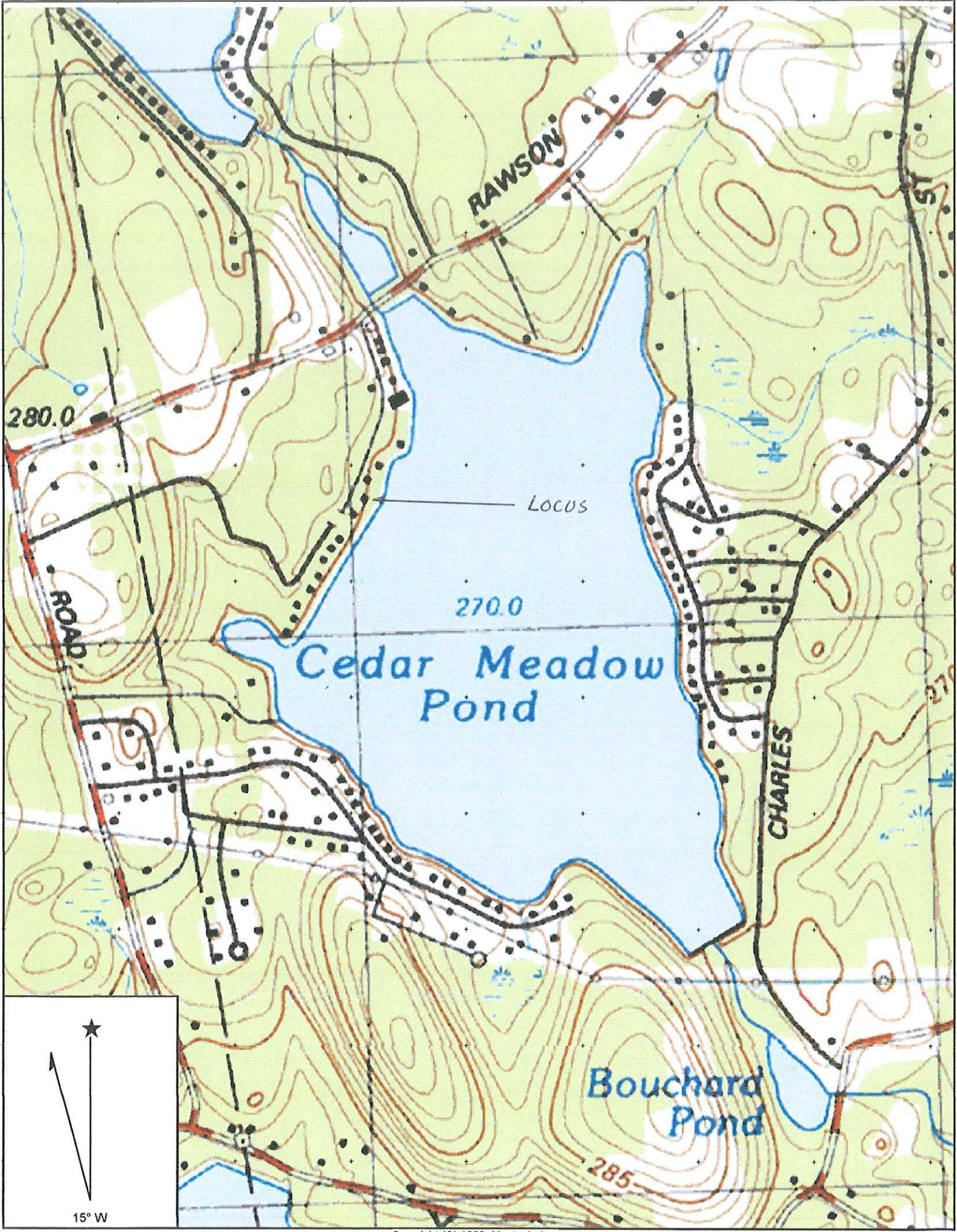
The wetlands resources on the property consist of a rip rapped shore line with a sandy beach, to more rip rapped shore line where a small intermittent stream enters the pond. The stream originates from an aquifer break out across Rawson drive, then it enters the property through a culvert where additional rip rap lines both banks of the stream until the stream enters the pond.

The stream is not on the USGS Topo. map as stated in the regulations and we have statements from the neighbors that the stream is dry in the summer.

All proposed work is not in close proximity to either the stream or the pond and the greatest precautions will be taken to protect the stream and the pond.

The Delineation method utilized was to identify the staining on the rocks located along the pond and the stream , also the washing and debris on the beaches , the figures were checked against each other for accuracy. The measurements were gathered with a total station and a prism pole held at the stain line as mentioned above. Flags were not utilized because the HWL was obvious and it would be tough to accurately flag the rocks.
