Overview

• \$950,000 to replace 7 pieces of 18-30 year old Highway equipment

Equipment has major safety, mechanical and physical deterioration

• Benefits include improved services for residents and reduced equipment maintenance costs (including labor)

Why a Debt Exclusion?

• Historic inability to fund large equipment replacement due to budgetary constraints

• Insufficient funding in annual operating budget for large capital purchases

• Annual Capital Plan (\$200,000-\$300,000 for all departments) can only cover small purchases

Impact on Tax Rate

- Adds \$0.24 per \$1000 valuation to the tax rate
- Impact on taxes for average single family home (\$218,000):
 - \$53 in Year 1
- Amount declines over the 5 year life of loan:
 - Ends at \$46 in Year 5

Service Improvement Areas

• Road repair and maintenance

• Snow removal operations

• Vegetative maintenance

• Street sweeping

• Drainage repair and maintenance

Approval Process

- Vote on Article 3 at the October 30th Town Meeting
- Vote on State Ballot Question 4 on November 6th
- Approval of both required for debt exclusion to pass
