Article 3. To see if the District will vote to hear a report from the Treasurer, or to take any action thereon.

Article 4. To see if the District will vote to elect a District Clerk to hold office for a term of one year or until the next Annual Meeting, or to take any action thereon.

Article 5. To see if the District will vote to elect a District Treasurer to hold office for a term of one year or until the next Annual Meeting, or to take any action thereon.

Article 6. To see if the District will vote by ballot to elect a member of the Management Committee for a term of three (3) years, or to take any action thereon.

Article 7. To see if the District will vote to accept the Cedar Meadow Lake 2024 - 2025 Action Plan as shared with the Proprietors, or to take any action thereon.

Article 8. To see if the District will vote to carry forward and/or transfer funds as described in a document as shared with the Proprietors, or to take any action thereon.

Article 9. To see if the District will vote to approve the Fiscal Year 2025 budget as shared with the Proprietors, the appropriation of monies to be raised by assessment upon the Proprietors in support thereof, or to take any action thereon.


Article 10. To see if the District will vote to discuss any other business that may properly come before this meeting, or to take any action thereon.




