Annual Meeting Notice

Warrant Articles:

- Article 1. To elect a moderator to serve for the term of one year, or take any action thereon.
- Article 2. To elect a clerk to serve for a term of one year, or take any action thereon.
- Article 3. To elect one Sewer Commissioner to serve for a term of three years, or take any action thereon.
- Article 4. To hear the reports of the Sewer Commissioners, Treasurer, and committees, or take any action thereon.
- Article 5. To see if the District will authorize the treasurer, with the approval of the Board of Sewer Commissioners, to borrow money from time to time for the Fiscal Year beginning July 1, 2017, in accordance with Massachusetts General Laws, Chapter 44, Section 4, and to issue any note or notes, as may be given for a period not to exceed one year, in accordance with the provisions of Massachusetts General Laws, Chapter 44, Section 17, or to take any action thereon.
- Article 6. To see if the District will vote to raise and appropriate or transfer from available funds a sum of money to the Sewer System Stabilization Account, or to take any action thereon.
- Article 7. To see if the District will vote to raise and appropriate and transfer from available funds such sums of money as may be needed to defray the charges and expenses of the District for the Fiscal Year beginning July 1, 2017, or to take any action thereon.
- Article 8. To see if the District will vote to transfer a sum of money to the 2017 Operating Budget as may be necessary to defray the expenses of the District for the fiscal year beginning July 1, 2016 or take any action thereon.

The listings of matters are those reasonably anticipated by the chair 48 hours before said meeting, which may be discussed at the meeting. Not all items listed may in fact be discussed and other items not listed may also be brought up for discussion to the extent permitted by law. Items may or may not require the Board's action.
