- Article 1. To elect a moderator to serve for the term of one year, or take any action thereon. To elect a clerk to serve for a term of one year, or take any action thereon. Article 2. To elect one Sewer Commissioner to serve for a term of three years, or take any action thereon. Article 3.
- To hear the reports of the Sewer Commissioners, Treasurer, and committees, or take any action thereon. Article 4.
