Warrant of Annual District Meeting - May 15, 2018

To: Sandra M. Wilson, District Clerk

You are herby directed to notify the voters of the Hillcrest Sewer District to meet at the Leicester Water Supply District's Meeting Hall, 124 Pine St. Leicester, Massachusetts at 7:00 P.M. on Tuesday, May 15, 2018 to act upon the following:

Article 1. To elect a moderator to serve for the term of one year, or take any action thereon. To elect a clerk to serve for a term of one year, or take any action thereon. Article 2. Article 3. To elect one Sewer Commissioner to serve for a term of three years, or take any action thereon. To hear the reports of the Sewer Commissioners, Treasurer, and committees, or take any action Article 4. thereon. To see if the District will authorize the treasurer, with the approval of the Board of Sewer Article 5. Commissioners, to borrow money from time to time for the Fiscal Year beginning July 1, 2018, in accordance with Massachusetts General Laws, Chapter 44, Section 4, and to issue any note or notes, as may be given for a period not to exceed one year, in accordance with the provisions of Massachusetts General Laws, Chapter 44, Section 17, or to take any action thereon. To see if the District will vote to raise and appropriate or transfer from available funds a sum of Article 6. money to the Sewer System Stabilization Account, or to take any action thereon. Article 7. To see if the District will vote to raise and appropriate and transfer from available funds such sums of money as may be needed to defray the charges and expenses of the District for the Fiscal Year beginning July 1, 2018, or to take any action thereon. To see if the District will vote to transfer a sum of money to the 2018 Operating Budget as may be Article 8. necessary to defray the expenses of the District for the fiscal year beginning July 1, 2017 or take any action thereon. To see if the District will vote to raise and appropriate or transfer a sum of money to fund an Article 9. Inflow & Infiltration study required by the MA Department of Environmental Protection, or take any action thereon.

And you are hereby directed to serve this warrant by posting an attested copy thereof at the Leicester Town Hall, Leicester Public Library, and the diner on Pleasant St. in the district, not less than seven (7) days prior to the date of said Meeting.
