

- ARTICLE 1. To elect a Moderator to serve a term of One Year.
- ARTICLE 2. To elect one Sewer Commissioner for a term of Three Years.
- ARTICLE 3. To hear the reports of the Sewer Commissioners.
- ARTICLE 4. To see if the District will vote to authorize the Treasurer, with the approval of the Board of Sewer Commissioners, to borrow money from time to time, in anticipation of revenue for the Fiscal Year beginning July 1, 2022 in accordance with Massachusetts General Laws, Chapter 44, Section 4, and to issue any note or notes, as may be given for a period not exceed one year, in accordance with the provisions of Massachusetts General Laws, Chapter 44, Section 17, or to take any action thereto.
- ARTICLE 5. To see if the District will vote to raise and appropriate such sums of money as may be needed to defray the charges and expenses of the District for the Fiscal Year beginning July 1, 2022, or to take any action thereto.
- ARTICLE 6 To see if the District will vote to raise and appropriate or transfer from available funds a sum of money for repairs to Clarifier #2 and install a mixing system in sludge tank #3 or to take any action thereto.

And you are hereby directed to serve this warrant by posting an attested copy Thereof in at least two public places in each of the Towns of Oxford and Leicester, and within The District, not less than seven (7) days prior to the date of said Meeting.


