Greeting:

IN THE NAME OF COMMONWEALTH OF MASSACHUSETTS, you are hereby directed to notify and warn the inhabitants of the Oxford-Rochdale Sewer District, qualified to vote in the Oxford-Rochdale Sewer District elections and affairs, to meet at the St. Aloysius-St. Jude Parish Hall, 489 Pleasant Street, Leicester, MA. On May 23, 2023 at 7:30 P.M. then and there to act on the following:

- ARTICLE 1. To elect a Moderator to serve a term of One Year.
- ARTICLE 2. To elect one Sewer Commissioner for a term of Three Years.
- ARTICLE 3 To elect one Sewer Commissioner for a term of Two Years
- ARTICLE 4. To hear the reports of the Sewer Commissioners.
- ARTICLE 5. To see if the District will vote to authorize the Treasurer, with the approval of the Board of Sewer Commissioners, to borrow money from time to time, in anticipation of revenue for the Fiscal Year beginning July 1, 2023 in accordance with Massachusetts General Laws, Chapter 44, Section 4, and to issue any note or notes, as may be given for a period not exceed one year, in accordance with the provisions of Massachusetts General Laws, Chapter 44, Section 17, or to take any action thereto.
- ARTICLE 6. To see if the District will vote to raise and appropriate such sums of money as may be needed to defray the charges and expenses of the District for the Fiscal Year beginning July 1, 2023, or to take any action thereto.
- ARTICLE 7 To see if the District will vote to raise and appropriate or transfer from available funds a sum of money for repairs to Clarifier #2 or to take any action thereto.
- ARTICLE 8 To see if the District will vote to raise and appropriate or transfer from available funds a sum of money to pay off the remaining borrowing from treatment plant note R-4
- ARTICLE 9 To see if the District will vote to authorize the commissioners to negotiate with the commissioners from the Hillcrest Sewer District regarding the merger of the Hillcrest Sewer District within their districts into the Oxford-Rochdale Sewer District boundaries, or to take any action thereon.

And you are hereby directed to serve this warrant by posting an attested copy Thereof in at least two public places in each of the Towns of Oxford and Leicester, and within The District, not less than seven (7) days prior to the date of said Meeting.
