
IN THE NAME OF COMMONWEALTH OF MASSACHUSETTS, you are hereby directed to notify and warn the inhabitants of the Oxford-Rochdale Sewer District, qualified to vote in the Oxford-Rochdale Sewer District elections and affairs, to meet at the St. Aloysius-St. Jude Parish Hall, 489 Pleasant Street, Leicester, MA. On June 16, 2020, at 7:30 P.M. then and there to act on the following:

- ARTICLE 1. To elect a Moderator to serve a term of One Year.
- ARTICLE 2. To elect one Sewer Commissioner for a term of Three Years.
- ARTICLE 3. To hear the reports of the Sewer Commissioners.
- ARTICLE 4. To see if the District will vote to authorize the Treasurer, with the approval of the Board of Sewer Commissioners, to borrow money from time to time, in anticipation of revenue for the Fiscal Year beginning July 1, 2019 in accordance with Massachusetts General Laws, Chapter 44, Section 4, and to issue any note or notes, as may be given for a period not exceed one year, in accordance with the provisions of Massachusetts General Laws, Chapter 44, Section 17, or to take any action thereto.
- ARTICLE 5. To see if the District will vote to raise and appropriate such sums of money as may be needed to defray the charges and expenses of the District for the Fiscal Year beginning July 1, 2020, or to take any action thereto.
- ARTICLE 6. To see if the District will vote to accept the provisions of G.L. c. 32B, § 10, authorizing the District to provide a plan of contributory group general or blanket hospital, surgical, medical and other insurance, for its employees; or to take any other action thereon.
- ARTICLE 7. To see if the District will vote to accept the provisions of G.L. c. 32B, § 7A, authorizing the District to make contribution payments in excess of fifty percent (50%) for group insurance; or to take any other action thereon.

ARTICLE 8. To see if the District will vote pursuant to the provisions of G.L. c. 32B, § 9A, to pay one-half of the premium cost payable by retired employees for group general or blanket hospital, surgical, medical and other insurance, to become effective July 1, 2020, or to take any other action thereon.

And you are hereby directed to serve this warrant by posting an attested copy Thereof in at least two public places in each of the Towns of Oxford and Leicester, and within The District, not less than seven (7) days prior to the date of said Meeting.

HERE OF FAIL NOT, and make due return of this warrant with your doing Thereon, to the Commissioners of the Oxford-Rochdale Sewer District, at the time and place of said Meeting, as fore said. Given under our hands, this 8<sup>th</sup> day of June, in the year of Our Lord, Two Thousand Twenty.


