IN THE NAME OF COMMONWEALTH OF MASSACHUSETTS, you are hereby directed to notify and warn the inhabitants of the Oxford-Rochdale Sewer District, qualified to vote in the Oxford-Rochdale Sewer District elections and affairs, to meet at the St. Aloysius-St. Jude Parish Hall, 489 Pleasant Street, Leicester, MA. On May 10, 2017, at 7:30 P.M. then and there to act on the following:

- ARTICLE 1. To elect a Moderator to serve a term of One Year.
- ARTICLE 2. To elect one Sewer Commissioner for a term of Three Years.
- ARTICLE 3. To hear the reports of the Sewer Commissioners.
- ARTICLE 4 To see if the District will vote to authorize the Treasurer, with the approval of the Board of Sewer Commissioners, to borrow money from time to time, in anticipation of revenue for the Fiscal Year beginning July 1, 2017 in accordance with Massachusetts General Laws, Chapter 44, Section 4, and to issue any note or notes, as may be given for a period not exceed one year, in accordance with the provisions of Massachusetts General Laws, Chapter 44, Section 17, or to take any action thereto.
- ARTICLE 5 To see if the District will vote to raise and appropriate such sums of money as may be needed to defray the charges and expenses of the District for the Fiscal Year beginning July 1, 2017, or to take any action thereto.
- ARTICLE 6 To see if District will vote to raise and appropriate or transfer from available funds a sum of money to the Wastewater Treatment Plant Stabilization account Or to take any action thereto.
