**INVITATION TO BID**

The Town of Leicester is seeking bids for road resurfacing. Sealed bids will be received at the Office of the Town Administrator, 3 Washburn Square, Leicester, MA 01524 until April 25, 2024, at 2:00 p.m. Bids will be opened publicly at that time.

Work consists of removal of existing bituminous pavement by cold planer, followed by repaving with Class I bituminous pavement. The Contractor shall provide all equipment necessary for cold planing, hauling of all removed materials and cleaning of surface in preparation of pavement. There may be roadways that will require keyways up to three feet wide that will not be cold planed; they will be resurfaced only. Hot bituminous concrete pavement will be placed in the same locations as directed by the DPW Director or Foreman. This pavement shall be machine laid in one (1) top course at one-half (1 1/2) inches in compacted thickness with a leveler only as needed.

The work shall include roadways and any other paved areas encountered in the work. Resurfacing will not be strictly limited to the areas disturbed, when in the judgment of the DPW Director or Foreman, an expansion of the work is necessary for proper restoration.

MassDOT prequalification of contractors with the class of work as Pavement - Surfacing for the project with an estimated value of \$952,117.02 will be required.

Bids shall be addressed to the Town of Leicester and should be submitted in the form specified, in a sealed envelope endorsed "Roadway Improvements – Town of Leicester" with the bidder's name and address. Entire project must be completed and invoiced by September 30, 2024.

Each bidder shall enclose with the bid an acceptable bid bond in the amount of five percent (5%) of the bid's value on the form specified.

The Town of Leicester reserves the right to reject any or all bids and to waive any informalities in bidding and to make the award as appears to the best interests of the Town.

**1.00 - Scope of Work:**

Work consists of material removing and repaving, as specified below:

**Removal of existing pavement by cold planer.** The Contractor shall provide all equipment necessary for cold planing, hauling of all removed materials and cleaning of surface in preparation of pavement. There may be roadways that will require keyways up to three feet wide that will not be cold planed; they will be resurfaced only.

Materials removed shall become the property of the Town of Leicester. All materials shall be deposited at the Leicester Department of Public Works, located at 50 Peter Salem Road, Leicester, MA 01524.

**Repaving of planed areas.** After cold planing has been completed, and the DPW has made other improvements to the roadway as necessary, hot bituminous concrete pavement will be placed in the same locations as directed by the DPW Director or Foreman. This type of pavement shall be composed of mineral aggregate, mineral filler, and bituminous material. This pavement shall be machine laid in one (1) top course at one-half (1 1/2) inches in compacted thickness with a leveler only as needed, as directed by the Superintendent or Foreman.

The work shall include roadways and any other paved areas encountered in the work. Resurfacing will not be strictly limited to the areas disturbed, when in the judgment of the Superintendent or Foreman, an expansion of the work is necessary for proper restoration.

The Contractor will be responsible for any water problems that occur when resurfacing has been completed.

This contract for this bid shall be for the removal of approximately 99,702 square yards of materials and the application approximately 9,246.50 tons of Class I bituminous concrete pavement installed in place. Award of this bid does not guarantee the removal or purchase of any specific quantity of materials by the Town.

**1.01 - Materials:**

All bituminous and incidental materials used in the work shall conform to the requirements of the "Massachusetts Department of Public Works – Standard Specification for Highways and Bridges – 2021 Edition" unless specifically stated otherwise herein.

Bituminous concrete surfacing materials shall conform to Section 460, Class I Bituminous Concrete Pavement of said Mass. D.P.W. Specification. Gradations of mix will be as directed by the Superintendent or Foreman to suit the use intended. Binder pavement will be followed by overlay pavement.

Tack coating shall be done with an approved bituminous tacking material spread along the contact area at all joints. Joint sealing shall be done with hot bituminous or other approved sealing compounds poured onto the rolled joint followed by a fine sand covering.

The material for the bituminous concrete berms shall consist of Class I Bituminous Concrete, Type 1 in accordance with the requirements for dense mix.

The cross-section of the berm shall be as directed or as approved by the DPW Director or Foreman before installation into the work.

**1.02 – Construction Methods**

All construction methods shall conform to the applicable provisions of the “Massachusetts Department of Public Works – Standard Specifications for Highways and Bridges – 2021 Edition” unless specially stated otherwise herein.

**1.02a - Cold Planing:** The cold planer must be equipped with an elevation device capable of loading planed materials directly into dump trucks while operative. It shall have all necessary safety devices such as reflectors, headlights, taillights, flashing lights, and back up signals so as to operate safely in traffic both days and nights.

The cold planer shall have the ability to plane flexible pavements and to plane cement concrete patch when encountered in bituminous pavement. It shall be self-propelled and have the means for planing without tearing or gouging the underlying surface. Variable lacing patterns shall be provided to permit a rough or grooved surface as directed.

The depth to be determined by the DPW Director or Foreman shall be no less than one and one-half (1 1/2) inch cut to predetermine grade of any specified lesser depth may be required in one pass. The minimum width of pavement planed in each pass shall be six feet, except in areas to be trimmed and edged. The machine shall be adjustable as to crown and depth and meet the standards set by the Air Quality Act for noise and air pollution.

The milled or planed surface shall conform generally to the grade and cross slope required. The surface shall not be torn, gouged, shoved, broken or excessively grooved. It shall be free of imperfections in workmanship that prevent resurfacing after this operation, surface texture shall be as specified by the DPW Director or Foreman. Excess material shall be removed so that the surface is acceptable to traffic as required.

All structures, manholes and gate boxes shall be cleaned free of any old bituminous concrete to make room for new material.

Hand work will be required along different areas of the project.

The Contractor will be responsible for all traffic control and police detail. A traffic plan must be approved by the Leicester Police Department and the DPW Director or Foreman.

**1.02b – Paving with Class I Bituminous Concrete Pavement:** The mixtures shall be transported from the plant to the work in vehicles previously cleaned of all foreign materials; the body shall be evenly and lightly coated with a suitable thin oil; each load shall be fully covered at all times with a canvas.

The dispatching of trucks from the plant shall be so arranged that all materials which are delivered at the site, in any one day, may be placed and shall have received final compaction before nightfall the same day.

The equipment for spreading and finishing shall be mechanical self-powered pavers, capable of spreading and finishing the mixture true to line, grade, width, and crown required without the use of forms or side supports and approved by the Director or Foreman.

When an existing surface upon which the bottom or top course is to be placed contains unsatisfactorily irregularities, in the Director's or Foreman's judgment, such irregularities shall be eliminated by an adequate placing and compaction of mixture so as to furnish a surface with a true contour and grade before placing any actual set course of mixture.

The contact surfaces of manholes, catch basins or other appurtenant structures in pavement shall be painted thoroughly with a thin uniform coating of bitumen just before any mixture is placed against them.

Spreading by hand methods will be permitted only for particular locations in the work, which because of irregularity, inaccessibility or other unavoidable obstacles do not allow mechanical spreading and finishing. Hand spreading and raking shall be carefully and skillfully done to avoid segregation and so that, after the first passage of the roller over the raked mixture, no back patching will be necessary.

After the paving mixture has been properly spread, compaction shall be obtained by the use of power rollers weighing not less than 285 pounds per inch width of tread. Each roller shall be operated by a competent, experienced roller operator and shall be kept in as nearly continuous operation as practicable while work is underway. The mixture shall be rolled longitudinally, diagonally, and transversely as may be necessary to produce the required contour for the surface.

Along curbs, structures, and all places not accessible with a roller, the mixture shall be thoroughly compacted with tampers. Such tampers shall weigh not less than twenty-five

(25) pounds and shall have a tamping face of not more than fifty (50) square inches. The surface of the mixture after compaction shall be smooth and true to the established line and grade.

Where and as directed, longitudinal and transverse joints for both top and bottom coursed placed under this or previous contracts shall be cut back to expose the full depth of the course and, when the laying of the course is resumed, the exposed edge of the joint shall be painted with a thin of bitumen. The new mixture shall be carefully raked against the joint and thoroughly tamped and rolled.

If at any time before the final acceptance of the work any soft, imperfect places or spots shall develop in the surface, all such places shall be removed and replaced with new material and then compacted until the edges of which the new work connects with the old becomes invisible. All such removal and replacement of unsatisfactory surfacing shall be done by the contractor as part of the payment made to him for the relevant contract items.

The machine formed bituminous concrete berm shall be placed on the bituminous concrete base course as shown on the plans. Irregularities, which exist in the base course, shall be brought to true line and grade with a leveling course, placed and compacted prior to the installation of the berm. Before placing the berm, a tack coat shall be painted on the existing pavement.

The mixture shall be placed and compacted with a machine acceptable and approved by the Superintendent or Foreman for the type of berm required.

If, at any time before acceptance of the work, any soft or imperfect spots develop in the exposed surface of the berm, they shall be removed and replaced with new material without any additional compensation to the contractor.

**1.02c – Project Completion:**

The project must be completed by September 30, 2024.

**1.03 - Method of Measurement**

**1.03a – Cold Planing:** Compensation for cold planing will be based upon square yards planed for the following roads (all depths to be 1 ½ inches). Item 103a shall be measured and paid for at Contract unit price per square yard, which price shall include all labor, materials, equipment, and incidentals required to complete the work.

**1.03b – Paving with Class I Bituminous Concrete Pavement:**

Compensation for bituminous concrete pavement for roadways shall be based upon the weight in tons of bituminous concrete actually placed into the work and approved and certified by weight slips. All weight slips are to be countersigned by the Superintendent or Foreman upon delivery. Tack coating shall be considered as incidental work under this item and not to be included for payment as a separate item.

Compensation for berms shall be based upon the weight in tons of dense mix bituminous concrete actually placed into the work. Said weight shall be certified by weigher's slips and countersigned by the Superintendent or Foreman upon delivery. Item 103b shall be measured and paid for at Contract unit price per square yard, complete in place, which price shall include all labor, materials, equipment, and incidentals required to complete the work.

Surplus material on a truckload will be deducted from the slip weight in an amount agreed to by the Contractor and Director or Foreman. For purposes of this contract, a square yard of bituminous concrete compacted in a 1-inch layer is equivalent to .06 tons of bituminous concrete.

**1.04 - Basis of Payment**

**1.04a – Cold Planing:** Cold Planing services shall be billed by the vendor based on the measured sections listed above and shall be full compensation for furnishing, hauling, placing, and compacting all materials, the preparation of all materials, supplying of equipment and tools, cleaning the surface of the existing roadway where required, and all other incidental work necessary to complete the work as specified. The vendor is encouraged to check the measurement and bring any perceived discrepancies to the attention of the DPW Director or Foreman prior to commencing work.

**1.04b – Paving with Class I Bituminous Concrete Pavement:** Class I. Bituminous Concrete Pavement, Type I-1 will be paid for at the unit price stated in the Bid for each ton satisfactorily placed into the work, and shall be full compensation for furnishing, hauling, placing, and compacting all materials, the preparation of all materials, supplying of equipment and tools, cleaning the surface of the existing roadway where required, and all other incidental work necessary to complete the work as specified. The vendor is encouraged to check the measurement and bring any perceived discrepancies to the attention of the DPW Director or Foreman prior to commencing work.

**2.00 – Bid Information**

This bid is governed by the bidding instructions appearing within.

**2.01 - Time and Place for Receipt of Bids:**

- a. Bids will be received at the Office of the Town Administrator, 3 Washburn Square, Leicester, Massachusetts 01524, addressed to the Leicester Town Administrator, until 2:00 p.m., April 25, 2024, at which time they will be opened publicly.
- b. Bids received after the time established for the receipt of bids shall not be considered regardless of the cause for delay in the receipt of such bid.
- c. Specifications may be obtained at the Office of the Town Administrator or by email at [bids@leicesterma.org](mailto:bids@leicesterma.org).
- d. There will be a meeting of potential Bidders in the Select Board meeting room on April 11, 2024 at 2:00 pm.
- e. Inquiries regarding the work should be directed to [bids@leicesterma.org](mailto:bids@leicesterma.org) Questions are due by April 16, 2024, at 2:00 pm. Responses to questions will be posted on Commbuys and emailed to all plan holders.

**2.02 - Modification of Bids:**

Modification of a bid will not be considered unless received in writing prior to the time respectively established for the opening of general bids

**2.03 - Withdrawal of Bids:**

Bids may be withdrawn prior to the time established for the opening of bids only by written request to the Town Administrator.

**2.04 - Interpretation of Contract Documents:**

- a. The intent of this invitation to bid is to receive bids for cold planing and the furnishing and placing of hot bituminous concrete pavement and berms into the work at locations as directed by the Superintendent or Foreman.
- b. No oral interpretation will be made to any bidder. Every interpretation requested shall be made in writing. No such request received within three days of the date established for the opening of bids will be given consideration.
- c. Every interpretation made to a bidder will be in the form of an addendum to the specifications, which will be sent to all persons to whom the contract documents have been issued. All such addenda shall become a part of the contract documents.
- d. Failure of the awarding authority to send, or of any bidder to receive, any such interpretation shall not relieve any bidder from any obligation under his submitted bid.

**2.05 - Bid Security:**

- a. Each bidder shall enclose with his/her bid an acceptable bid bond or bid deposit in an amount of five percent (5%) of the bid's value. Bid bonds must be issued by a surety company, qualified to do business in Massachusetts, and payable to the "Town of Leicester". Bid deposits must be in the form of a certified check, treasurer's check, or cashier's check drawn on a responsible bank or trust company and made payable to the "Town of Leicester".
- b. The selected bidder will be required to provide a fifty percent (50%) payment bond upon entering into a contract with the Town.
- c. Should any bidder to whom an award is made fail to enter into a contract therefore within ten (10) days Sundays and holidays excepted, after presentation by the awarding authority, or fail within such time to furnish a performance bond or payment bond as required, the amount so received from such bidder through his certified check, treasurer's or cashier's check shall become the property of the Town of Leicester for liquidated damages for such failure.

**2.06 - Contract Awards:**

- a. The Town of Leicester reserves the right to reject any or all bids and to waive any informalities in bidding and/or to make the award for all or any part of the work to be done, as appears to the best interests of the Town.

- b. The Contract will be awarded based on the lowest responsive and responsible bidder as determined by the Town. In determining the same, the financial responsibility of the bidder will not be the sole criteria. The Town is equally concerned with the proven and probable ability of the bidder to satisfactorily perform his contract, so that work will be completed on time and in accordance with the contract. A sample contract is attached to this IFB.
- c. All bid deposits will be returned after the successful bidder, if any, is determined. The successful bidder will be required to furnish an insurance certificate(s), naming the Town as an additional insured, and a 50% payment bond.
- d. It is expected that the work will be performed with all due expedience and will be fully completed and invoiced prior to September 30, 2024.
- e. The Town of Leicester reserves the right to terminate any and all parts of the contract if the contractor fails to comply with the terms of the contract.

**3.00 – General Conditions**

This bid is governed by the general conditions appearing within.

**3.01 - Character of Workers**

The Contractor shall employ only competent workers to work on Town projects, and whenever the Contractor shall be notified by the Town in writing that any person on the work is, in its opinion, incompetent, unfaithful, disorderly, or otherwise unsatisfactory, such a person shall be removed and shall not be re-employed except with the written consent of the Town Administrator.

**3.02 - Definitions**

The words “approved”, or “acceptable”, “satisfactory”, “necessary”, or words of like import, where they appear in these specifications, shall mean approved by, acceptable to, satisfactory to, or necessary in the opinion of the Town of Leicester acting through its Town Administrator or other duly authorized representative.

**3.03 - Insurance and Bonds**

- 1. Before starting the work, the Contractor shall supply the Town of Leicester with insurance certificates covering public liability, property damage and worker’s compensation, which will protect the Contractor from claims for damages that may occur as a result of the performance of the work specified herein for the Town of Leicester. The limits of such insurance shall be as follows:

2. Insurance certificates shall show the Town of Leicester to be an additionally named insured on all policies pertaining to the work to be performed. All policies shall be written by companies qualified to do business in Massachusetts.

**3.04 - Bidder Qualifications**

1. Each bidder must have a minimum of five (5) years-experience cold planing and in the installation and paving with Class I. Bituminous Concrete Pavement and must submit evidence of having done such work.
2. Contractor must have been in business for a minimum of five (5) years with the same business name.
3. To be considered qualified, each bidder will provide a list of references on the form provided. References must be for work performed in the Commonwealth of Massachusetts.
4. All other forms included in the packet (Bid Form, Affidavit of Non-Collusion, and Attestation Certification) must be completed and enclosed in the bid packet for the bid to be determined to be complete.
5. Current Contractor's Corporate License must be provided with the bid submission.

**3.05 - Responsibility of the Contractor**

1. The Contractor shall conform to all requirements of State and local laws and regulations. Supervision and Workmanship
2. The Contractor shall be fully responsible for the proper installation and repair of all items specified in keeping with the best trade practices, or as otherwise specified herein and for the finished appearance of all related work.
3. All work shall be performed in a thorough and skillful manner and shall be done at such times as may be for the best interests of the project as a whole. All labor shall be compatible and there shall be no conflict with other contract labor that may be performing other contract work in the area.
4. The Contractor shall conform to all requirements of State and local laws and regulations.

**3.06 - Social Security**

The Contractor shall furnish the Town of Leicester with the Employer's Identification Number under the Federal Social Security Program as a condition of the Contract.

**3.07 - Safety**

Care shall be taken by the Contractor to protect from damage or injury any person or any equipment or property on the site that may result because of the performance of the work. All federal, local, and state safety requirements shall be complied with.

In accordance with M.G.L. 30, Section 39S(a), the successful bidder must certify that all employees to be employed at the worksite have successfully completed a course in construction safety and health approved by the United States Occupational Safety and Health Administration (OSHA) that is at least 10 hours in duration. Documentation shall be submitted with the first certified payroll report for each employee of the successful completion of said course.

**3.08 - Rubbish**

The Contractor shall remove from the premises all dirt, rubbish, refuse, etc., caused by the Contractor's operations, and shall leave the premises, at the termination of the Contract, in a condition satisfactory to the Town of Leicester or its representative(s).

**3.09 - Wage Rates**

The work must be done in accordance with the requirements of both local and state laws applicable thereto. The Contractor shall comply with the requirements of Chapter 149, Sections 26 and 27 of the General Laws of the Commonwealth of Massachusetts. (Wage rates attached.) In addition, the Contractor will be required to provide the Town with weekly certified payrolls and payroll records reports and statements of compliance for all work performed.

**3.10 - Addendum**

In the case of any ambiguity, inconsistency, error, or omission in any of the bid documents, or a conflict between the provisions in a governmental regulation, the bidder is required to draw such matters to the attention of David Genereux, Town Administrator, who will, in turn, clarify the situation as to the true interpretation thereof and notify each and every person who has received the bid documents through the issuance of an Addendum. The Town of Leicester will not be held responsible for any oral instructions. If the bidder fails to draw such matters to the attention of the Assistant to the Town Administrator as outlined herein, then his/her bid conclusively will be presumed to have been based upon the interpretation which may be given subsequently by the Town

Administrator, or, if such conflict is with a law or regulation, the bid conclusively is presumed to be predicated upon full compliance therewith.

**3.11 - Taxes**

Purchases by the Town of Leicester are exempt from any federal, state, or municipal sales and/or excise taxes.

**3.12 - Bid Form**

The price that the bidder proposes must be typewritten or written in ink in the space(s) provided on the Bid Form. In the event of discrepancy between the unit price and the extension, the unit price will govern. The Town of Leicester assumes no responsibility to recalculate totals if an award is made on the basis of totals.

**3.13 - Bid Documents**

The bidder is to familiarize him/herself thoroughly with all the documents enumerated herewith, as it is conclusively understood that all bids are based upon full compliance with the various provisions contained in said documents. The bid documents consist of: INVITATION TO BID; GENERAL CONDITIONS; SPECIFIC CONDITIONS (if any); SPECIFICATIONS (if any); BID FORM, AFFIDAVIT OF NON-COLLUSION, ATTESTATION CERTIFICATION, and PERFORMANCE REFERENCES. One complete set of documents is to be returned, properly signed, and executed.

**3.14 – Price Adjustment Notice**

In accordance with MGL Chapter 303 Section 60 and Chapter 86 of the Acts of 2008, this contract shall be subject to the provisions relative to energy escalation. A price adjustment for liquid asphalt and Portland cement shall be made on a monthly basis when the monthly change exceeds +/- 5 percent. Base prices for this contract shall be the New Method period prices posted on the MassDOT website at the following link for the month of the Contract bid opening: [MassDOT Contract Price Adjustments | Mass.gov](#) See Attachment A for further details on the monthly price adjustments for hot mix asphalt (HMA) mixtures and diesel fuel and gasoline.

**3.15 – Prequalification:**

Contractors must be pre-qualified (or officially waived contractor) with the Massachusetts Department of Transportation at the time of submitting their bid to the Town. The MassDOT Prequalification Office will provide the Town with an official and a waiver contractor list for all contractors prequalified in the specified class of work within the parameters of this project. Only those bidders listed in the official or waiver contractor lists issued by the MassDOT Prequalification Office will be allowed

to submit a bid and receive an award of contract. MassDOT prequalification of contractors with the class of work as Pavement - Surfacing for the project with an estimated value of \$952,117.02 will be required.

**3.16 – Public Safety and Convenience:**

The Contractor shall provide necessary access for fire apparatus and other emergency vehicles through the work zones to abutting properties at all times.

Sweeping and cleaning of surfaces beyond the limits of the project to clean up material caused by spillage or vehicular tracking during the various phases of the work shall be considered as incidental to the work being performed under the Contract and there will be no additional compensation.

The Contractor shall make his own investigation to assure that no damage to existing structures, drainage lines, traffic signal conduits, and other utilities will occur as a result of his operations.

**3.17 – Protection of Underground Facilities:**

The Contractor, in constructing or installing facilities alongside or near sanitary sewers, storm drains, water or gas pipes, electric or telephone conduits, poles, sidewalks, walls, vaults or other structures shall, at his expense, sustain them securely in place, cooperating with the officers and agents of the various utility companies and municipal departments which control them, so that the services of these structures shall be maintained. #### 6. Term of Contract and Time for Performance:

#### 7. Subject to Appropriation:

#### 8. Permits and Approvals:

Permits, Licenses, Approvals and all other legal or administrative prerequisites to its performance of the Contract shall be secured and paid for by the Contractor.

#### 9. Termination and Default:

- 9.1 Without Cause. The Town may terminate this Contract on seven (7) calendar days-notice when in the Town’s sole discretion it determines it is in the best interests of the Town to do so, by providing notice to the Contractor, which shall be in writing and shall be deemed delivered and received when given in person to the Contractor, or when received by fax, express mail, certified mail return receipt requested, regular mail postage prepaid or delivered by any other appropriate method evidencing actual receipt by the Contractor. Upon termination without cause, Contractor will be paid for services rendered to the date of termination.
- 9.2 For Cause. If the Contractor is determined by the Town to be in default of any term or condition of this Contract, the Town may terminate this Contract on seven (7) days-notice by providing notice to the Contractor, which shall be in writing and shall be deemed delivered and received when given in person to the

Contractor, or when received by fax, express mail, certified mail return receipt requested, regular mail postage prepaid or delivered by any other appropriate method evidencing actual receipt by the Contractor.

9.3 Default. The following shall constitute events of a default under the Contract:

any material misrepresentation made by the Contractor to the Town; 2) any failure to perform any of its obligations under this Contract including, but not limited to the following: (i) failure to commence performance of this Contract at the time specified in this Contract due to a reason or circumstance within the Contractor's reasonable control, (ii) failure to perform this Contract with sufficient personnel and equipment or with sufficient material to ensure the completion of this Contract within the specified time due to a reason or circumstance within the Contractor's reasonable control, (iii) failure to perform this Contract in a manner reasonably satisfactory to the Town, (iv) failure to promptly re-perform within a reasonable time the services that were rejected by the Town as unsatisfactory, or erroneous, (v) discontinuance of the services for reasons not beyond the Contractor's reasonable control, (vi) failure to comply with a material term of this Contract, including, but not limited to, the provision of insurance and non-discrimination, (vii) any other acts specifically and expressly stated in this Contract as constituting a basis for termination of this Contract, and (viii) failure to comply with any and all requirements of state law and/or regulations, and Town bylaw and/or regulations.

10. Suspension or Delay

The Town may order the Contractor, in writing, to suspend, delay or interrupt all or any part of the Services without cause for such period of time as the Town may determine to be appropriate for its convenience. In the event of any such suspension, delay or interruption, the Contractor's compensation shall be equitably adjusted. No adjustment shall be made if the Contractor is or otherwise would have been responsible for the suspension, delay, or interruption of the Services, or if another provision of this Contract is applied to render an equitable adjustment.

11. The Contractor's Breach and the Town's Remedies:

Failure of the Contractor to comply with any of the terms or conditions of this Contract shall be deemed a material breach of this Contract, and the Town of Leicester shall have all the rights and remedies provided in the Contract documents, the right to cancel, terminate, or suspend the Contract in whole or in part, the right to maintain any and all actions at law or in equity or other proceedings with respect to a breach of this Contract, including "Damages" including but not limited to costs, attorney's fees or other damages resulting from said breach ("Damages") as well as specific performance, and the right to select among the remedies available to it by all of the above.

From any sums due to the Contractor for services, the Town may keep the whole or any part of the amount for expenses, losses and Damages incurred by the Town as a consequence of procuring services as a result of any failure, omission, or mistake of the Contractor in providing services as provided in this Contract.

12. Statutory Compliance:

- 12.1 This Contract will be construed and governed by the provisions of applicable federal, state, and local laws and regulations; and wherever any provision of the Contract or Contract documents shall conflict with any provision or requirement of federal, state, or local law or regulation, then the provisions of law and regulation shall control. Where applicable to the Contract, the provisions of the General Laws are incorporated by reference into this Contract, including, but not limited to, the following:

General Laws Chapter 30B – Procurement of Goods and Services.

General Laws Chapter 30, Sec. 39, *et seq.* - Public Works Contracts.

General Laws Chapter 149, Section 44A, *et seq.* Public Buildings Contracts.

- 12.2 Wherever applicable law mandates the inclusion of any term and provision into a municipal contract, this Section shall be understood to import such term or provision into this Contract. To whatever extent any provision of this Contract shall be inconsistent with any law or regulation limiting the power or liability of cities and towns, such law or regulation shall control.
- 12.3 The Contractor shall comply with all Federal, State, and local laws, rules, regulations, policies, and orders applicable to the Work provided pursuant to this Contract, such provisions being incorporated herein by reference, and shall be responsible for obtaining all necessary licenses, permits, and approvals required for the supply of such Work.

The Contractor shall indemnify and hold the Town harmless for and against any and all fines, penalties or monetary liabilities incurred by the Town as a result of the failure of the Contractor to comply with the previous sentence. If any discrepancy or inconsistency is discovered in the Drawings, Specifications or Contract for this work in violation of any such law, by-law, regulation, order, or decree, it shall forthwith report the same in writing to the Town. It shall, at all times, itself observe and comply with all such existing and future laws, by-laws, regulations, orders, and decrees; and shall protect and indemnify the Town, and its duly appointed agents against any claim or liability arising from or based on any violation whether by him or its agents, employees, or subcontractors of any such law, by-law, regulation, or decree.

### 13. Conflict of Interest:

Both the Town and the Contractor acknowledge the provisions of the State Conflict of Interest Law (General Laws Chapter 268A), and this Contract expressly prohibits any activity which shall constitute a violation of that law. The Contractor shall be deemed to have investigated the application of M.G.L. c. 268A to the performance of this Contract; and by executing the Contract documents the Contractor certifies to the Town that neither it nor its agents, employees, or subcontractors are thereby in violation of General Laws Chapter 268A.

### 14. Certification of Tax Compliance

This Contract must include a certification of tax compliance by the Contractor, as required by General Laws Chapter 62C, Section 49A (Requirement of Tax Compliance by All Contractors Providing Goods, Services, or Real Estate Space to the Commonwealth or Subdivision).

### 15. Non-Discrimination/Affirmative Action

The Contractor shall carry out the obligations of this Agreement in compliance with all requirements imposed by or pursuant to federal, State and local ordinances, statutes, rules and regulations and policies prohibiting discrimination in employment, including but not limited to, Title VII of the Civil Rights Act of 1964; the Age Discrimination in Employment Act of 1967; Section 504 of the Rehabilitation Act of 1973 and Mass. G. L. c. 151B, and any other executive orders, rules, regulations, requirements and policies relating thereto enacted by the Commonwealth of Massachusetts and the Town as they may be amended from time to time. Contractor shall not discriminate against any qualified employee or applicant for employment because of race, color, national origin, ancestry, age, sex, religion, physical or mental handicap or sexual orientation.

- 15.1 As used in this section "affirmative action" means positive steps to ensure all qualified persons equal employment opportunity without regard to race, color, religion, sex, or national origin at all stages of the

15.2 The Contractor, if applicable, shall include in all compliance and progress reports submitted to the town a report which shall include: (a) A certificate stating that he or she is currently in compliance with the provisions of G.L. c. 152B and setting forth the Affirmative Action he or she is currently undertaking and will undertake during the contract period to provide equal employment opportunity for all qualified persons without regard to race, color, religion, sex or national origin; and (b) A statement in writing supporting information signed by an authorized officer or agent on behalf of any labor union or other agency which refers workers or provides or supervises apprenticeship or other training programs which the Contractor deals, to the effect that the union or other agency's practices and policies do not discriminate on the basis of race, color, religion, sex or national origin; provided, in the event that the union or other agency shall refuse to execute such a statement, the Contractor need only so certify in writing.

15.3 A copy of any such report as described above, shall be filed in the office of the Town Clerk and shall upon said filing become a public record.

15.4 The Contractor will take Affirmative Action to ensure that employees are solicited and employed, and that employees are treated during employment, without regard to race, color, religion, sex, or national origin.

15.5 The Contractor will in all solicitation or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, or national origin.

15.6 In determining whether steps taken by the Contractor constitute Affirmative Action, the Town shall consider the relevant characteristics of the Contractor including, but not limited to, the number of employees and the location of the principal and branch offices.

16. Assignment:

The Contractor shall not assign, sublet, or otherwise transfer this Agreement, in whole or in part, without the prior written consent of the Town, and shall not assign any of the moneys payable under this Contract, except by and with the written consent of the Town.

17. Condition of Enforceability Against the Town:

This Contract is only binding upon, and enforceable against, the Town if: (1) the Contract is signed by the Board of Selectmen or its designee; and (2) endorsed with approval by the Town Accountant as to appropriation or availability of funds, and (3) endorsed with approval by the Town Counsel as to form.

18. Corporate Contractor:

If the Contractor is a corporation, it shall endorse upon this Contract (or attach hereto) its Clerk's Certificate certifying the corporate capacity and authority of the party signing this Contract for the corporation. Such certificate shall be accompanied by a letter or other instrument stating that such authority continues in full force and effect as of the date the Contract is executed by the Contractor. This Contract shall not be enforceable against the Town of Leicester unless and until the Contractor complies with this section.

The Contractor, if a foreign corporation, shall file with the Commissioner of Corporations a Power of Attorney and duly authenticated copies of its Charter or Certificate of Incorporation; and said Contractor shall comply with all the laws of the Commonwealth.

19. Contractor's Personnel:

The Contractor shall utilize only its employees and shall not utilize any third-party contractors without prior written approval of the Town.

20. Liability of Public Officials:

To the full extent permitted by law, no official, employee, agent or representative of the Town of Leicester shall be individually or personally liable on any obligation of the Town under this Contract.

21. Indemnification:

The Contractor shall indemnify, defend and save harmless the Town, the Town's officers, agents and employees, from and against any and all damages, liabilities, actions, suits, proceedings, claims, demands, losses, costs, expenses, recoveries and judgments of every nature and description (including attorneys' fees) that may arise in whole or in part out of or in connection with the work being performed or to be performed, or out of any act or omission by the Contractor,

its employees, agents, subcontractors, material men, and anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, regardless of whether or not it is caused in part by any party indemnified hereunder. The Contractor further agrees to reimburse the Town for damage to its property caused by the Contractor, its employees, agents, subcontractors or material men, and anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, including damages caused by his, its or their use of faulty, defective, or unsuitable material or equipment, unless the damage is caused by the Town's gross negligence or willful misconduct.

- 21.1 The Contractor further agrees to indemnify and hold harmless the Town, including the agents, employees and representatives of either, from and against all claims, damages, losses and expenses, including attorney's fees, arising out of or resulting from the performance of the work, provided that any such claim, damage, loss or expense (a) is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property including the loss of use resulting therefrom and (b) is caused in whole or in part by any negligent act or omission of the Contractor, any Subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, regardless of whether or not it is caused in part by a party indemnified hereunder.
- 21.2 The Contractor shall be responsible for all damage or injury to property of any character during the prosecution of the work resulting from any act, omission, neglect, or misconduct in the manner or method of executing the work or due to the non-execution of the work or at any time due to defective work or materials.
- 21.3 In any and all claims against the town or any of their agents or employees by any employee of the Contractor, any Subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, the indemnification obligation under this paragraph shall not be limited in anyway by any limitation on the amount or type of damages, compensation or benefits payable by or for the Contractor or any Subcontractor under workmen's Compensation Acts, disability benefit acts or other employee benefit acts.
- 21.4 The Contractor hereby assumes the entire responsibility and liability for any and all injury to or death of any or all persons, including the Contractor's employees, and for any and all damage to property caused by, resulting from or arising in whole or in part out of any act, omission, or neglect on the part of the Contractor or of any Subcontractor or of anyone directly or indirectly employed by any of them, or of anyone for whose acts any of them may be liable in connection with operations under the Contract.

The foregoing provisions shall not be deemed to be released, waived, limit or modified in any respect by reason of any surety or insurance provided by the Contractor under the Contract.

## 22. Insurance

### 22.1 Workers Compensation Insurance:

The Contractor shall provide by insurance for the payment of compensation and the furnishing of other benefits under Chapter 152 of the General Laws of Massachusetts (The Worker's Compensation Act) to all employees of the Contractor who are subject to the provisions of Chapter 152 of the General Laws of Massachusetts.

Failure to provide and continue in force such insurance during the period of this Contract shall be deemed a

material breach of this Contract, shall operate as an immediate termination thereof, and Contractor shall indemnify the Town for all losses, claims, and actions resulting from the failure to provide the insurance required by this Article.

The Contractor shall furnish to the Town a certificate evidencing such insurance prior to the execution of this Contract before the same shall be binding on the parties thereto, except if specifically waived by the Town.

## 22.2 Professional Liability Insurance

Liability of \$1 million per claim and \$3 million aggregate.

Failure to provide and continue in force such insurance during the period of this Contract shall be deemed a material breach of this Contract, shall operate as an immediate termination thereof, and Contractor shall indemnify the Town for all losses, claims, and actions resulting from the failure to provide the insurance required by this Article.

## 22.3 Other Insurance Requirements

- a. Comprehensive commercial general liability insurance with limits of at least \$1 Million per occurrence and \$3 Million annual aggregate for property damage and \$1 Million per person and \$3 Million per occurrence for bodily injury, which shall include the Town of Leicester as an additional insured, and which shall cover bodily injury, sickness or disease, or death of any person including employees and those persons other than the Contractor's employees, and claims insured by usual personal liability coverage, death, or property damage arising out of the Work including injury or destruction of tangible property, including loss of use resulting therefrom.
- b. Motor vehicle insurance for any motor vehicles used in performing the Work, with limits of at least \$500,000 per person, and \$1 Million per accident.
- c. The intent of the Specifications regarding insurance is to specify minimum coverage and minimum limits of liability acceptable under the Contract. However, it shall be the Contractor's responsibility to purchase and maintain insurance of such character and in such amounts as will adequately protect it and the Town from and against all claims, damages, losses, and expenses resulting from exposure to any casualty liability in the performance of the work, including and not limited to Professional liability insurance where applicable.
- d. All policies shall identify the Town as an additional insured (except Workers' Compensation). The Contractor shall notify the Town immediately upon the cancellation or amendment to any policy. Renewal Certificates shall be filed with the Town at least ten (10) days prior to the expiration of the required policies. Certificates evidencing all such coverage shall be provided to the Town upon the execution of this Agreement, and upon the renewal of any such coverage. Each such certificate shall specifically refer to this Contract and shall state that such insurance is as required by this Contract. **Failure to provide the notices required in this Section or to continue in force such insurance shall be deemed a material breach of this Contract and shall be grounds for immediate termination.** Said insurance shall include Workers Compensation/Employers' Liability Insurance, Business Automobile Liability Insurance,

and Commercial General Liability Insurance (CGL). The CGL policy shall include coverage for liability arising from premises, operations, independent Contractors, personal injury, contractual liability. All Certificates of Insurance shall be on the "MIIA" or "ACORD" Certificate of Insurance form, shall contain true transcripts from the policies, authenticated by the proper officer of the Insurer, evidencing in particular those insured, the extent of coverage, the location, and operations to which the insurance applies, the expiration date and the above-mentioned notice clauses. All insurance shall be written on an occurrence basis. Coverages shall be maintained without interruption from date of the Contract until date of final payment and termination of any coverage required to be maintained after payment.

- e. The Contractor shall obtain and maintain during the term of this Contract the insurance coverage in companies licensed to do business in the Commonwealth of Massachusetts and acceptable to the Town.

### 23. Documents, Materials, Etc.

Any materials, reports, information, data, etc. given to or prepared or assembled by the Contractor under this Contract are to be kept confidential and shall not be made available to any individual or organization by the Contractor (except agents, servants, or employees of the Contractor) without the prior written approval of the Town, except as otherwise required by law. The Contractor shall comply with the provisions Chapter 66A of the General Laws of Massachusetts as it relates to public documents, and all other state and federal laws and regulations relating to confidentiality, security, privacy and use of confidential data.

Any materials produced in whole or in part under this Contract shall not be subject to copyright, except by the Town, in the United States or any other country. The Town shall have unrestricted authority to, without payment of any royalty, commission, or additional fee of any type or nature, publicly disclose, reproduce, distribute, and otherwise use, and authorize others to use, in whole or in part, any reports, data or other materials prepared under this Contract.

All data, reports, programs, software, equipment, furnishings, and any other documentation or product paid for by the Town shall vest in the Town at the termination of this Contract. The Contractor shall at all times, during or after termination of this Contract, obtain the prior written approval of the Town before making any statement bearing on the work performed or data collected under this Contract to the press or issues any material for publication through any medium.

### 24. No Employment

The Contractor acknowledges and agrees that it is acting as an independent Contractor for all services rendered pursuant to this Contract, and neither the Contractor, nor its employees, agents, servants nor any person for whose conduct the Contractor is responsible shall be considered an employee or agent of the Town for any purpose and shall not file any claim or bring any action for any worker's compensation unemployment benefits and compensation for which they may otherwise be eligible as a Town employee as a result of work performed pursuant to the terms of this Contract.

### 25. Audit, Inspection and Recordkeeping

At any time during normal business hours, and as often as the Town may deem it reasonably necessary, there shall be available in the office of the Contractor for the purpose of audit, examination, and/or to make excerpts or transcript all



records, contracts, invoices, materials, payrolls, records of personnel, conditions of employment and other data relating to all matters covered by this Agreement.

## 26. Payment

The Town agrees to make all reasonable efforts to pay to the Contractor the sum set forth in the Contractor's bid or proposal within thirty (30) days of receipt of an invoice detailing the work completed and acceptance from the Town of the work completed.

## 27. Waiver and Amendment

Amendments, or waivers of any additional term, condition, covenant, duty, or obligation contained in this Contract may be made only by written amendment executed by all signatories to the original Agreement, prior to the effective date of the amendment.

To the extent allowed by law, any conditions, duties, and obligations contained in this Contract may be waived only by written Agreement by both parties.

Forbearance or indulgence in any form or manner by a party shall not be construed as a waiver, nor in any manner limit the legal or equitable remedies available to that party. No waiver by either party of any default or breach shall constitute a waiver of any subsequent default or breach of a similar or different matter.

## 28. Severability

If any term or condition of this Contract or any application thereof shall to any extent be held invalid, illegal, or unenforceable by the court of competent jurisdiction, the validity, legality, and enforceability of the remaining terms and conditions of this Contract shall not be deemed affected thereby unless one or both parties would be substantially or materially prejudiced.

## 29. Forum and Choice of Law

This Contract and any performance herein shall be governed by and be construed in accordance with the laws of the Commonwealth. Any and all proceedings or actions relating to subject matter herein shall be brought and maintained in the courts of the Commonwealth or the federal district court sitting in the Commonwealth, which shall have exclusive jurisdiction thereof. This paragraph shall not be construed to limit any other legal rights of the parties.

## 30. Notices

Any notice permitted or required under the provisions of this Contract to be given or served by either of the parties hereto upon the other party hereto shall be in writing and signed in the name or on the behalf of the party giving or serving the same. Notice shall be deemed to have been received at the time of actual service or three (3) business days after the date of a certified or registered mailing properly addressed. Notice to the Contractor shall be deemed

SUPPLEMENT "C" - Applicable to Contracts for the construction of:

(1) Public Buildings and Public Works

(Governed by the provisions of General Laws Chapter 30B);

(2) Public Buildings

(Governed by the provisions of General Laws Chapter 149, § 44A, et seq.); and

(3) Public Works

(Governed by the provisions of General Laws Chapter 30, §39M, et seq)

1. This form supplements the Town of Leicester "Contract and General Conditions" and applies only to contracts for the construction, reconstruction, alteration, remodeling or repair of public works or public buildings.
2. Wherever the law requires one contracting with a city or town to be bonded, such obligation shall be understood to be a term and condition of this Contract. The Contractor agrees to secure such bond (where required) in the form required by the Town and provide an original thereof to the Town prior to the commencement of performance.
3. Equality:
  - 3.1. In the case of a closed Specification written for a specific item or items to be furnished under the Base Bid, such specifications shall, as applicable, be in compliance with the Massachusetts General Laws, Chapter 30, Section 39M and Chapter 149, Sec. 44A et seq.
  - 3.2. Where the name of an item, material or manufacturer is mentioned in the Specifications or on the Drawings, except as above noted, the intent is to establish a standard and in no way should be construed to exclude any item or manufacturer not mentioned by name, but whose product meets the Specifications as to design, utility, and quality. Final decision shall rest solely with the Town's Project Representative (herein after "Project Representative") as to its acceptability.
4. Change Orders:
  - 4.1. Change orders must receive the approval of the Town Administrator and the appropriate Department or Division Head and must be supported by the project engineers and architects, if any.
  - 4.2. Change orders to contracts governed by General Laws Chapter 30B may not increase the quantity of goods or services provided by more than twenty-five (25%) per cent, in compliance with Sec. 13 of Chapter 30B.
5. The Contractor will carry out the obligations of this contract in full compliance with all of the requirements imposed by or pursuant to General Laws Chapter 151, Sec. 1, et seq. (Minimum Wage Law) and any executive orders, rules, regulations, and requirements of the Commonwealth of Massachusetts as they may from time to time be amended. The Contractor will at all times comply with the wage rates as determined by the Commissioner of the Department of Labor and Industries, under the provisions of General Laws Chapter 149, Sections 26 and 27D (Prevailing Wage), as shall be in force and as amended.
6. The Contractor shall continuously maintain adequate protection of all work from damage and shall protect the

property of the Town and others, including adjacent property, from injury or loss arising in connection with the Contract. The Contractor shall make good any such damage, injury, or loss, except as may be directly due to errors in the Contract Documents or caused by agents or employees of the Town, or due to causes beyond the Contractor's control and not the Contractor's fault or negligence.

7. The Contractor shall take all necessary precautions for the safety of employees on the work, and shall comply with all applicable provisions of Federal, State, and local laws and codes to prevent accidents or injury to persons on, about or adjacent to the premises where the work is being performed. The Contractor will erect and properly maintain at all times, as required by the conditions and progress of the work, all necessary safeguards for the protection of workers and the public, shall post danger signs warning against the hazards created by such features of construction such as pits, protruding nails, hoists, well holes, elevator hatchways, scaffolding, window openings, stairways and falling materials; and shall designate a responsible member of its organization on the work, whose duty shall be the prevention of accidents.
8. The Town shall at all times have access to the work wherever it is in preparation or progress and the Contractor shall provide suitable accommodations for such access.
9. The Contractor shall appoint a competent superintendent and foreman and any necessary assistants, all of whom shall be satisfactory to the Town. If the Town in its sole discretion determines that the construction superintendent, foreman, or assistants are unacceptable to the Town, then upon seven days-notice from the Town, the Contractor shall replace such person or persons with people acceptable to the Town.
10. The Contractor shall give efficient supervision to the work, using its best skill and attention. The Contractor shall carefully study and compare the drawings, specifications and other instructions and shall at once report to the Town any error, inconsistency or omission which shall be discovered. Included in this responsibility shall be supervision of all work performed by subcontractors on the work.
11. Notwithstanding any other provision of this Contract to the contrary, if the Contractor should neglect to prosecute the work properly or fail to perform the contract or any of its provisions, the Town, upon three days written notice, may, without prejudice to any other remedy it may have, make good such deficiencies, and may deduct the cost thereof from the payment then or thereafter due the Contractor.
12. Inspection by the Town's Project Representative
  - 12.1. The Town shall have the right to designate a Project Representative who may make periodic visits to the site to familiarize the Town generally with the progress and quality of the work, and to determine in general if the work is proceeding in accordance with the Contract Documents. The Project Representative will not be required to make exhaustive or continuous on-site inspections to check the quality or quantity of the work and will not be responsible for the Contractor's failure to carry out the construction work in accordance with the Contract Documents. During such visits and on the basis of these observations while at the site, the Project Representative will keep the Town informed on the progress of the work, will endeavor to guard the Town against defects and deficiencies in the work of contractors, and may condemn structural work as failing to conform to the Contract Documents. The Project Representative shall have authority to act on behalf of the Town only to the extent expressly delegated by the Town, which shall be shown to the Contractor, and shall have authority to stop the work whenever such stoppage may reasonably be necessary to insure the proper execution of the Contract.
  - 12.2. In connection with the work, the Project Representative shall not be responsible for construction methods, means, techniques, sequences, or procedures employed by the Contractor or the Contractor's safety programs, requirements, regulations, or precautions.

13. Decisions of the Project Representative

- 13.1. The Project Representative shall, within a reasonable time, make decisions on all claims of the Town or the Contractor and on all other matters relating to the execution and progress of the structural work or the interpretation of the Contract Documents.
- 13.2. The Project Representative's decision, in matters relating to the project, shall be final, if within the terms of the Contract Documents.
- 13.3. If, however, the Project Representative fails to render a decision within ten days after the parties have presented their evidence, either party may then avail itself of the remedies provided in this Contract or available to it by law. If the Project Representative renders a decision after such remedies have commenced, such decision may be entered as evidence but shall not disturb or interrupt such proceedings except where such decision is acceptable to the parties concerned.

14. Use of Premises by the Contractor:

- 14.1. The Contractor shall confine its apparatus, the storage of materials and the operations of its workmen to limits indicated by law, by-laws, permits or directions of the Town and shall not unreasonably encumber the premises with its materials.
- 14.2. The Contractor shall not load or permit any part of the structure to be loaded with a weight that will endanger its safety.

15. Maintenance of Premises:

The Contractor shall at all times keep the premises free from accumulation of waste materials or rubbish caused by its employees or work, and at the completion of the work it shall remove all its rubbish from and about the work site and all its tools, scaffolding and surplus materials and shall leave its work "broom-clean", or its equivalent, unless more exactly specified. In case of dispute, the Town may remove the rubbish and charge the cost to the several contractors, as the Town shall determine to be just.

16. Right to Terminate

In addition to any other remedies herein provided and notwithstanding any other provisions hereof to the contrary, if the Contractor should (1) be adjudged a bankrupt, (2) make a general assignment for the benefit of creditors, (3) have a receiver appointed on account of its insolvency, (4) persistently or repeatedly refuse or fail to supply enough personnel and resources to perform the contract, (5) fail to make prompt payment to subcontractors or to providers of materials or labor, (6) persistently disregard laws and regulations or lawful directives of the Town, or (7) be guilty of a substantial violation of any provision of the Contract, then the Town may, without prejudice to any other right or remedy and after giving the Contractor (or any surety) seven days written notice, terminate the contract and the employment of the Contractor and take possession of the premises and of all materials, tools and appliances thereon and finish the work by whatever method it deems appropriate.

In such cases, the Contractor shall not be entitled to receive any further payment until the work is finished. If the unpaid amount owed to the Contractor for work already completed shall exceed the expense of finishing the work, including compensation for additional architectural, managerial, legal, and administrative services, such excess shall be paid to the Contractor. If such expenses shall exceed such unpaid balances, the Contractor shall pay the difference to the Town.

The Contractor shall not be relieved of liability to the Town by virtue of any termination of this Contract, and

any claim for damages against the Contractor relating to the Contractor's performance under this contract shall survive any termination hereunder.

Notwithstanding any other provision of this Agreement, the Town reserves the right at any time in its absolute discretion to suspend or terminate this Agreement in whole or in part for its convenience upon seven days written notice to the Contractor. The Town shall incur no liability by reason of such termination except for the obligation to pay compensation for all work performed by the Contractor and accepted by the Town to the termination date.

17. Progress Payments:

- 17.1. The Contractor shall submit to the Town an itemized Application for Payment, supported to the extent required by the Town by invoices or other vouchers, showing payments for materials and labor, payments to Subcontractors and such other evidence of the Contractor's right to payment.
- 17.2. The Contractor shall, before the first application, submit to the Town a schedule of values of the various parts of the work, including quantities aggregating the total sum of the Contract, divided so as to facilitate payments to Subcontractors, made out in such form as the Town and the Contractor may agree upon, and, if required, supported by such evidence as to its correctness. This schedule, when approved by the Town, shall be used as a basis for payment, unless it is found to be in error. If applying for payments, the Contractor shall submit a statement based upon this schedule.

18. Withholding of Payments

- 18.1. The Town may withhold or, on account of subsequently discovered evidence, nullify the whole or part of any payment to such extent as may be necessary in its reasonable opinion to protect the Town of Leicester from loss on account of:
  - 18.1.1. Defective work not remedied.
  - 18.1.2. Claims filed or reasonable evidence indicating probable filing of claims.
  - 18.1.3. Failure of the Contractor to make payments properly to Subcontractors or for material or labor.
  - 18.1.4. A reasonable doubt that the Contract can be completed for the balance then unpaid.
  - 18.1.5. Damage to another contractor.
  - 18.1.6. Delays resulting in liquidated damages.
- 18.2. Withholding of payments shall be in strict compliance with statutory requirements.

19. Claims by Contractor and Liability of Town

All claims by the Contractor against the Town shall, unless otherwise provided by law, be initiated by a written claim submitted to the Town no later than seven (7) calendar days after the event or the first appearance of the circumstances causing the claim. The claim shall set forth in detail all known facts and circumstances

supporting the claim. The Contractor shall continue its performance under this contract regardless of the submission or existence of any claims.

The limit of liability of the Town under this Agreement is limited to the compensation provided herein for work actually performed and shall in no event include liability for delays or for incidental, special or consequential damages or lost profits or for damages or loss from causes beyond the Town's reasonable control.

20. Damages for Delay:

The Contractor shall not have claims for any damages, costs, or expenses of any kind or nature, for any suspension, delay, interruption, or acceleration of the work on the part of the Town, architect, or any of their consultants in performing or furnishing any work, or resulting from problems or deficiencies with materials, information, or documentation and/or decisions in connection with the execution of the work. The Contractor's sole remedy for such delay shall be for a claim for an extension of time to its period of contract performance.

21. The Contractors' Mutual Responsibility:

Should the Contractor cause damage to any separate subcontractor on the work, the Contractor agrees, upon due notice, to settle with such contractor by agreement, or by recourse to remedies provided by law or by the provisions of the contract. If such separate contractor sues the Town on account of any damage alleged to have been sustained, the Town shall notify the Contractor, who shall defend such proceedings at the Town's expense and, if any judgment against the Town arises therefrom, the Contractor shall pay or satisfy it and pay all costs incurred by the Town including attorney's fees and related costs of litigation.

22. Separate Contracts:

22.1. The Town reserves the right to let other Contracts in connection with this work under similar General Conditions. The Contractor shall afford other contractors' reasonable opportunity for the introduction and storage of their materials and the execution of their work and shall properly connect and coordinate its work with theirs.

22.2. If any part of the Contractor's work depends, for proper execution or results, upon the work of any other contractor, the Contractor shall inspect and promptly report to the Town any defects in such work that render it unsuitable for such proper execution and results. Failure of the Contractor to so inspect and report shall constitute an acceptance of the other contractor's work as fit and proper for the reception of its work except as to defects which may develop in the other contractor's work after the execution of its work.

22.3. To ensure the proper execution of its subsequent work, the Contractor shall measure work already in place and shall at once report to the Town any discrepancy between the executed work and the Drawings.

23. Subcontracts:

23.1. All Subcontracts shall be awarded in conformity with the requirements of the General Laws, Commonwealth of Massachusetts, Chapter 149, Sections 44A to 44L, inclusive.

23.2. The Contractor agrees that it is as fully responsible to the Town for the acts and omissions of its Subcontractors and of persons either directly or indirectly employed by them, as it is for the acts and omissions of persons directly employed by it.

23.3. Nothing contained in the Contract Documents shall create any contractual relationship between any Subcontractor and the Town.

24. Contractor-Subcontractor Relations:

The Contractor agrees to bind every Subcontractor and every Subcontractor agrees to be bound by the terms of the Agreement, the General Conditions of the Contract, the Supplementary General Conditions, the Drawings and Specifications, as far as applicable to its work, including the provisions of the General Laws, Commonwealth of Massachusetts, Chapter 149, Section 44A, et seq.

25. The Contractor's Insurance:

Notwithstanding any other provisions of this Contract to the Contrary and in addition to any requirements set forth in the Contract, the Contractor shall provide and maintain the following insurance:

25.1. The Contractor shall purchase and maintain such insurance as will protect the Contractor from claims set forth below which may arise out of or result from the Contractor's operations under the Contract, whether such operations be by itself or by any Subcontractor or by anyone directly or indirectly employed by any of them or by anyone for whose acts any of them may be liable.

25.2 Liability Insurance Requirements

In addition to the liability insurance requirements set forth in the Contract, the liability insurance shall include all major divisions and shall be on a comprehensive general basis including Premises and Operations, Owners and Contractor's Protective, Products and Completed Operations, and Owned, Non-owned and Hired Motor Vehicles. All such insurance shall be written for not less than any limits of liability required by law, unless otherwise provided in the contract documents. The Contractor's insurance shall include:

25.3. The above insurance policies shall also be subject to the following requirements:

25.3.1. Insurance coverage for the Contractor's Comprehensive General Liability, as hereinafter specified under Paragraph entitled "Protective Liability Insurance" shall be written by one and the same insurance company to avoid the expense of duplicate and/or overlapping coverage and to facilitate and expedite the settlement of claims.

25.3.2 All premium costs shall be included in the Contractor's bid.

26. Protective Liability Insurance:

26.1. The Contractor shall purchase and maintain such insurance as described in the preceding paragraph as will protect the Town from claims which may arise from operations under the Contract, including operations performed for the named insureds by independent contractors and general inspection thereof by the named insureds.

26.2. The Contractor shall also purchase and maintain such insurance as will protect the Town against



Automobile Non-Ownership Liability in connection with the Contractor's operations under the Contract, whether such operations be by itself or by any Subcontractor or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable.

- 26.3. The limits of liability for coverage required under the Contract shall be as specified within the Contract documents.

The Town shall be named as an additional insured on the above referenced liability Policies, and the Contractor's insurance shall be the primary coverage. The cost of such insurance, including required endorsements and amendments, shall be the sole responsibility of the Contractor.

27. Liens:

Neither the Final Payment nor any part of the retained percentage shall become due until the Contractor, if required, shall deliver to the Town a complete release of all liens arising out of the Contract, or receipts in full in lieu thereof and, if required in either case, an affidavit that as far as it has knowledge or information, the releases and receipts include all the labor and material for which a lien could be filed. The Contractor shall comply with all statutory provisions of the General Laws of the Commonwealth of Massachusetts with regard to liens, Chapter 254 and 149 as amended (as a minimum requirement).

28. Guarantees:

28.1. The Contractor guarantees and warrants to the Town that all labor furnished under this Contract will be competent to perform the tasks undertaken, that the product of such labor will yield only first-class results, that materials and equipment furnished will be of good quality and new unless otherwise permitted by this Contract, and that the Work will be of good quality, free from faults and defects and in strict conformance with this Contract. All Work not conforming to these requirements may be considered defective.

28.2. If at any time any part of the work constructed under the terms of this contract shall in the opinion of the Town Administrator require repairing due to defective work or materials furnished by the Contractor, he may notify the Contractor in writing to make the required repairs. If the Contractor shall neglect to start such repairs within ten days of the date of giving it notice thereof and to complete the same to the satisfaction of the Town Administrator with reasonable dispatch, then the latter may employ other persons to make such repairs. The Town shall charge the expense thereof to the Contractor and may use any moneys still retained to pay for the same, and if such sum is insufficient, the Contractor shall be obligated to pay the balance thereof.

28.3. All guarantees and warranties required in the various Sections of the Specifications which originate with a Subcontractor or Manufacturer must be delivered to the Town before final payment to the Contractor may be made for the amount of that subtrade or for the phase of work to which the guarantee or warranty relates. The failure to deliver a required guarantee or warranty shall be held to constitute a failure of the Subcontractor to fully complete his work in accordance with the Contract Documents. The Contractor's obligation to correct work is in addition to, and not in substitution of, such guarantees or warranties as may be required in the various Sections of the Specifications.

This provision applies to all projects using greater than 100 tons of hot mix asphalt (HMA) mixtures containing liquid asphalt cement as stipulated in the Notice to Contractors section of the bid documents.

The Price Adjustment will be based on the variance in price for the liquid asphalt component only from the Base Price to the Period Price. It shall not include transportation or other charges. This Price Adjustment will occur on a monthly basis

**BASE PRICE**

The Base Price of liquid asphalt on a project as listed in the Notice to Contractors section of the bid documents is a fixed price determined at the time of bid by the Department by using the same method as for the determination of the Period Price detailed below.

**PERIOD PRICE**

Please note that, starting December 15, 2008, two sets of period prices will be posted each month on the MassHighway website at <http://www.mhd.state.ma.us/>. They will be labeled "New Asphalt Period Price Method" and "Old Asphalt Period Price Method".

**NEW ASPHALT PERIOD PRICE METHOD**

The "New Asphalt Period Price Method" is for contracts bid after December 15, 2008 and will show the Period Price of liquid asphalt for each monthly period as determined by MassHighway using the average selling price per standard ton of PG64-28 paving grade (primary binder classification) asphalt, FOB manufacturer's terminal, as listed under the "East Coast Market - New England, Boston, Massachusetts area" section of the Poten & Partners, Inc. "Asphalt Weekly Monitor". This average selling price is listed in the issue having a publication date of the second Friday of the month and will be posted as the Period Price for that month. MassHighway will post this Period Price on this website within two (2) business days following their receipt of the relevant issue of the "Asphalt Weekly Monitor". Poten and Partners has granted MassHighway the right to publish this specific asphalt price information sourced from the Asphalt Weekly Monitor.

**OLD ASPHALT PERIOD PRICE METHOD**

The "Old Asphalt Period Price Method" Period Price will be for contracts bid on or before December 15, 2008 and will contain liquid asphalt prices as determined by the old or previous method. These prices will continue to be posted on MassHighway's website until all contracts using the "Old Asphalt Period Price Method" Period Price have been closed

**NEW AND OLD ASPHALT PERIOD PRICE METHODS**

The paragraphs below apply to both the New and the Old Asphalt Period Price Methods.

The Contract Price of the hot mix asphalt mixture will be paid under the respective item in the Contract. The price adjustment, as herein provided, upwards or downwards, will be made after the work has been performed, using the monthly period price for the month during which the work was performed.

The Price Adjustment applies only to the actual virgin liquid asphalt content in the mixture placed on the job in accordance with the Standard Specifications for Highways and Bridges, Division III, Section M3.11.03.

The Price Adjustment will be a separate payment item. It will be determined by multiplying the number of tons of hot mix asphalt mixtures placed during each monthly period times the liquid asphalt content

percentage times the variance in price between Base Price and Period Price of liquid asphalt. This Price Adjustment will be paid only if the variance from the Base Price is 5% or more for a monthly period. The complete adjustment will be paid in all cases with no deduction of the 5% from either upward or downward adjustments.

No Price Adjustment will be allowed beyond the Completion Date of this Contract, unless there is a department-approved extension of time.

**MONTHLY PRICE ADJUSTMENT FOR DIESEL FUEL AND GASOLINE  
ENGLISH UNITS  
Revised: 01/26/2009**

This monthly fuel price adjustment is inserted in this contract because the national and worldwide energy situation has made the future cost of fuel unpredictable. This adjustment will provide for either additional compensation to the Contractor or repayment to the Commonwealth, depending on an increase or decrease in the average price of diesel fuel or gasoline.

This adjustment will be based on fuel usage factors for various items of work developed by the Highway Research Board in Circular 158, dated July 1974. These factors will be multiplied by the quantities of work done in each item during each monthly period and further multiplied by the variance in price from the Base Price to the Period Price.

The Base Price of Diesel Fuel and Gasoline will be the price as indicated in the Department's web site ([www.mhd.state.ma.us](http://www.mhd.state.ma.us)) for the month in which the contract was bid, which includes State Tax. The Period Price will be the average of prices charged to the State, including State Tax for the bulk purchases made during each month.

This adjustment will be affected only if the variance from the Base Price is 5% or more for a monthly period. The complete adjustment will be paid in all cases with no deduction of the 5% from either upward or downward adjustments. No adjustment will be paid for work done beyond the extended completion date of any contract.

Any adjustment (increase or decrease) to estimated quantities made to each item at the time of final payment will have the fuel price adjustment figured at the average period price for the entire term of the project for the difference of quantity.

For construction projects lasting longer than one year, awarding authorities must request an updated wage schedule no later than two weeks before the anniversary of the date the contract was executed by the awarding authority and the general contractor. For multi-year CM AT RISK projects, the awarding authority must request an annual update no later than two weeks before the anniversary date, determined as the earlier of: (a) the execution date of the GMP Amendment, or (b) the execution date of the first amendment to permit procurement of construction services. The annual update requirement is not applicable to 27F "rental of equipment" contracts. **The updated wage schedule must be provided to all contractors, including general and sub-contractors, working on the construction project.**
- This wage schedule applies only to the specific project referenced at the top of this page and uniquely identified by the "Wage Request Number" on all pages of this schedule.
- An Awarding Authority must request an updated wage schedule if it has not opened bids or selected a contractor within 90 days of the date of issuance of the wage schedule. For CM AT RISK projects (bid pursuant to G.L. c.149A), the earlier of: (a) the execution date of the GMP Amendment, or (b) the bid for the first construction scope of work must be within 90-days of the wage schedule issuance date.
- The wage schedule shall be incorporated in any advertisement or call for bids for the project as required by M.G.L. c. 149, § 27. The wage schedule shall be made a part of the contract awarded for the project. The wage schedule must be posted in a conspicuous place at the work site for the life of the project in accordance with M.G.L. c. 149 § 27. The wages listed on the wage schedule must be paid to employees performing construction work on the project whether they are employed by the prime contractor, a filed sub-bidder, or a sub-contractor.
- Apprentices working on the project are required to be registered with the Massachusetts Division of Apprentice Standards (DAS). Apprentices must keep their apprentice identification card on their persons during all work hours on the project. An apprentice registered with DAS may be paid the lower apprentice wage rate at the applicable step as provided on the prevailing wage schedule. **Any apprentice not registered with DAS regardless of whether they are registered with another federal, state, local, or private agency must be paid the journeyworker's rate.**
- Every contractor or subcontractor working on the construction project must submit weekly payroll reports and a Statement of Compliance directly to the awarding authority by mail or email and keep them on file for three years. Each weekly payroll report must contain: the employee's name, address, occupational classification, hours worked, and wages paid. Do not submit weekly payroll reports to DLS. For a sample payroll reporting form go to <http://www.mass.gov/dols/pw>.
- Contractors with questions about the wage rates or classifications included on the wage schedule have an affirmative obligation to inquire with DLS at (617) 626-6953.
- Contractors must obtain the wage schedules from awarding authorities. Failure of a contractor or subcontractor to pay the prevailing wage rates listed on the wage schedule to all employees who perform construction work on the project is a violation of the law and subjects the contractor or subcontractor to civil and criminal penalties.
- Employees not receiving the prevailing wage rate set forth on the wage schedule may file a complaint with the Fair Labor Division of the office of the Attorney General at (617) 727-3465.
