BOARD OF REGISTRARS MINUTES OF JANUARY 26, 2016

Len Ivel called meeting to order at 5:09pm with Mike Curtis, Linda Rowden and Debbie Davis in attendance. Minutes were accepted for the December 1, 2015 meeting.

A motion to accept correction to voting machine – cost \$21,275.22 Voted unanimously.

Welcomed our newest Registrar – Michael Curtis
Prices reviewed for soft cases for machines and it was decided against- we are leaving the machines intact.

Purchased YES/NO ballots for Town Meetings and also a set of thumb drives - \$545

We were looking into getting the machines on line and any additional costs for this would come out of the \$28,000 that was put aside to purchase the new voting machines however the company is not ready. Previously accepted.

Wednesday February 10, 2016 8:00 am - 8:00 pm is last day to register to vote before the Presidential Primary. Deb Davis will work the late hours.

Discussed the Parties that are current for the Primary election: Democrat, Republican, UIP and Green Rainbow.

Absentee ballots are in: put on Website, notify the newspapers and Phil Robo to get the word out.

Reviewed Procedure for the Primary and also disposing of old voting machines and accepting the new machines. Send letter to Selectmen and to State Elections to dispose of old and accept the new machines. We will be using the new voting machines for the March Presidential Primary for the first time.

Hired a new census company the old one went out of business. Linda and I are designing the form and are very happy with it so far.
