BOARD OF REGISTRARS MINUTES FOR MAY 5, 2015

Len Ivel opened the meeting at 5:06 PM with Mary Ring, Debbie Davis and Linda Rowden present. Minutes were approved for the December 2, 2014 meeting.

We went over the set up for tonight's Town Meeting. There will be four tables with two clerks at each table to check voters in. We will be handing out Yes/No ballots as there is a possibility of ballot votes on two articles.

Wednesday, May 20th is the last day to register to vote before the June 9th election. The Town Clerk's office must be open from 8 to 8. Voting machines will be tested May 28th at 1:00. It was discussed if we should order more ballots than usual as we have five selectmen running for three seats and there may be a question on that the town be allowed to exempt from the provisions of two and one-half for the construction of a new fire station. First it must pass at the town meeting tonight. It was suggested to order 2,000 ballots.

The Board of Selectmen will be voting on the polling hours for the election, but we expect them to be 12 – 8 as they have been in the past. They also have to vote on the list of election workers that we have to submit to them.

We have to find a new company to do our street list since Copley Business Services informed they will not be doing them. We will have to find out the end of this year if they will be doing the census next year.

Meeting adjourned at 5:53 PM. No date was set for the next meeting.
