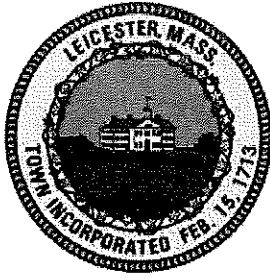

BOARD OF REGISTRARS MINUTES OF SEPTEMBER 8, 2016

Debbie opened the meeting at 5:00 with Len Ivel, Mike Curtis and Maureen Connery. Maureen was welcomed as the new registrar with the passing of Linda Rowden, who will be sadly missed.

The group was reorganized with Len Ivel as Chairman, Maureen Connery as Secretary - voted unanimously.

The discussion of Early Voting for the November 8, General Election was brought to the table. Early voting to be held October 24 to November 4.

Hours being M, W, Th 8-5, Tues 8-7 normal business hours

with extended hours being Tuesday 10/25 until 8 pm

Saturday 10/29 9:00am until 1:00pm

Tuesday, 11/1 until 8pm

Friday, 11/4, 9:00am to 12:00pm

The early voting hours would be posted in the local papers: T & G and the New Leader. Money for the ad will come out of the 500.00 grant provided by the State for Early Voting. The grant will also pay for the Saturday hours - workers and part of the police detail.

It was also discussed that the Town Clerk and Chairman would go to Becker College to recruit new voters on September 13 for 3 hours.

Set up of the Hall was discussed and it would not be able to set up for election until after the STM on November 1, 2016. We discussed the procedure for setting up STM on Nov 1, 2016. Being so close to the election and the fact that the voting machines will have already been tested for the Presidential election there will not be a voting machine available for the STM. If a count is called for on any article we could do a hand count.

Looking at the warrant, we are not expecting any surprises, we will give voting cards out- no ballots.

Early Voting- with the hours we have chosen for Early Voting the town will receive a \$500 scholarship which will be applied to the cost of Early Voting hours and help needed also the cost of advertising in the newspapers.

No minutes for two previous meetings due to Linda's passing, however we will be working on getting those typed up and accepted.

Presidential Election is November 8.

Len and Mike to be at Town Hall for 6:00 am to start machines.

Debbie to be at Town Hall for 5:00 am

Next meeting is November 1, 5:00 pm before STM.
