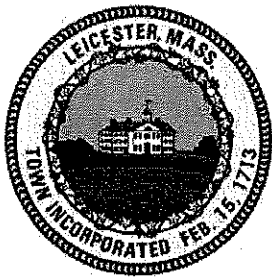
Place: Town Clerk's Office, 3 Washburn Square, Leicester, MA
