Dear Mr. Doray;

You have applied for a temporary Changeable sign located at 1323 Main Street, property owned by William Roberts and used as an auto body and car sales lot. The existing signs which were changed from the original sign (permit not applied for) contain 47 square feet total area and the temp sign that has been there since last July but not being used right now measures 32 square feet in area.

The zoning district the property is in, is the HB-1 district. In this district a sign can be up to 30 square feet total area by right and up to 50 square feet with a special permit under section 6.4.02 of the zoning by law.

The total area with all signs combined is 79 square feet.

At this time I Must deny your application based on the overage of square feet and the necessity as described in section 3.2.07-1 of the zoning by-laws; a special permit is required for a changeable sign along with a recommendation by the Leicester Police Chief to be allowed. You will also need to apply for a variance to the 50 square foot total area as described in section 3.2.07-2 A.




