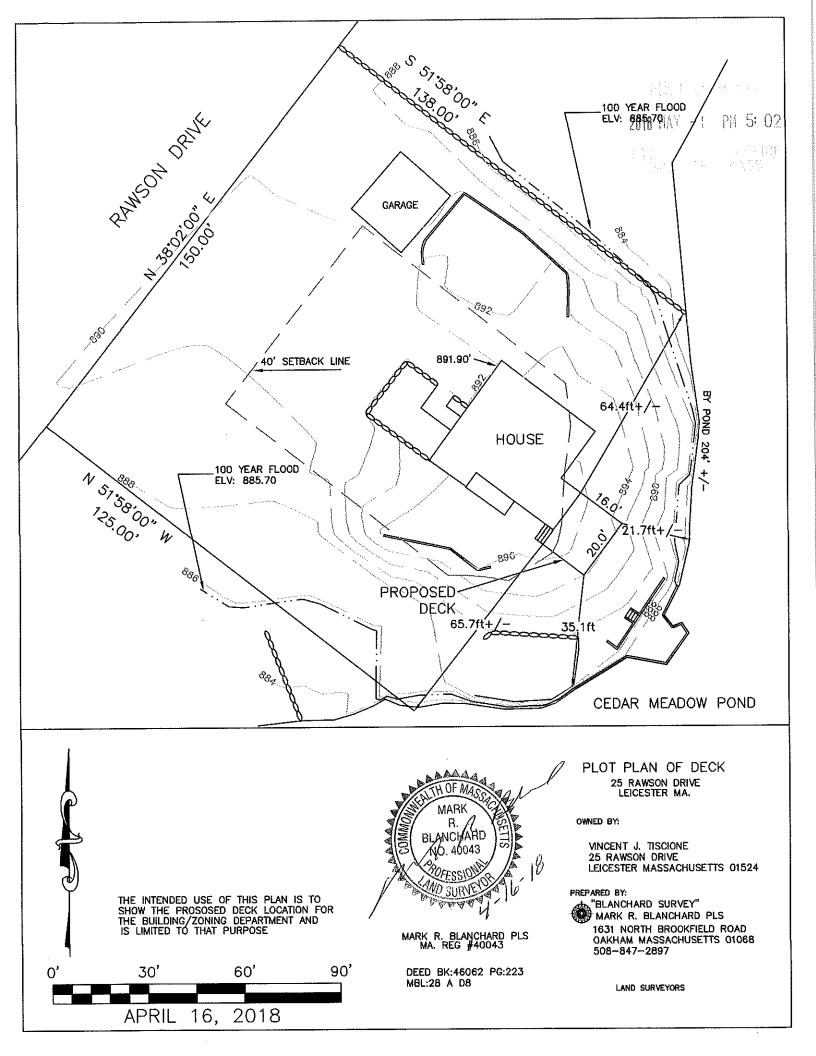
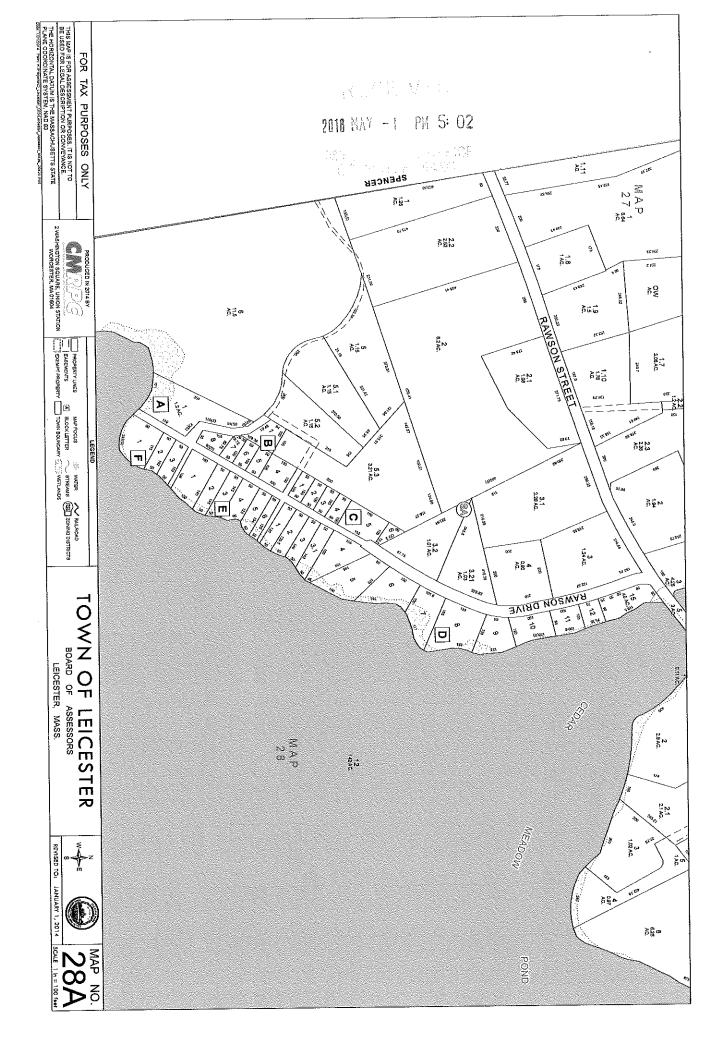

Dear Mr. Tiscone;

You have applied to add a deck to your existing home located at 25 Rawson Drive. Your property is in the Suburban Agricultural zoning district. In this district the setback requirements from all property lines is forty (40) feet. Your plot plan depicts the rear of the deck will be located twenty nine (29) feet from the rear property line.

I just received your determination today from the conservation commission and I must inform you your deck will be in the setback area and I must deny your application based on the plot plan information. Conservation has to be taken care of first before you can apply to the zoning board of appeals.

You will need to apply to the zoning board of appeals for a Variance to the setback requirements. Please see the town clerk for the application for a variance and follow the instructions included with the application.

I must also say the application was insufficient and information has been coming in piecemeal and a final review was completed today to find the variance issue.
